
HOUSE RESOLUTION

REQUESTING THE BOARD OF EDUCATION AND DEPARTMENT OF EDUCATION TO CONTINUE TO COLLABORATE WITH FAMILY AND COMMUNITY ORGANIZATIONS TO ESTABLISH, IMPLEMENT, AND MONITOR STATEWIDE POLICIES FOR FAMILY-SCHOOL PARTNERSHIPS IN HAWAII'S PUBLIC SCHOOLS.

1 WHEREAS, family-school partnerships are an important
2 indicator of student success and are important in a child's
3 cognitive, social, and emotional development; and
4

5 WHEREAS, children benefit from family-school partnerships,
6 including at the early childhood, elementary, middle or
7 intermediate, and high school levels; and
8

9 WHEREAS, family-school partnerships help close educational
10 gaps between children of different socioeconomic backgrounds;
11 and
12

13 WHEREAS, family-school partnerships in public education can
14 help to create policies, strategies, and practices that support
15 learning and improve student achievement; and
16

17 WHEREAS, in response to Senate Concurrent Resolution No.
18 145, Regular Session of 2011 (S.C.R. 145), and Senate Concurrent
19 Resolution No. 79, Regular Session of 2012 (S.C.R. 79), the
20 Department of Education, in collaboration with a working group
21 comprised of family and community organizations, completed the
22 following actions in preparation for updating and implementing
23 statewide policies for family-school partnerships:
24

- 25 (1) Presenting draft revisions to the Board of Education
26 of its Parent/Family Involvement Policy No. 2403 to
27 more accurately reflect the nature of the relationship
28 between students' families and their schools that the
29 Department wishes to promote, including renaming the
30 policy the "Family-School Partnership Policy" and
31 including standards adapted from the National Parent
32 Teacher Association Standards for Family-School
33 Partnerships; and

2 (2) Incorporating recommendations from the working group
3 into the Department of Education's strategic plan
4 regarding family satisfaction with school
5 responsiveness, and engaging parent and community
6 stakeholders; and

8 WHEREAS, the following actions are necessary to fulfill the
9 legislative intent of S.C.R. 145 and S.C.R. 79:

11 (1) Adoption by the Board of Education of revisions to its
12 Parent/Family Involvement Policy No. 2403 to
13 incorporate the suggestions of the working group, and
14 collaboration with family and community organizations
15 to monitor the implementation of the policy;
16
17 (2) Update and align the Board of Education's Student
18 Support Policy No. 2203 to reflect advancements in
19 research and practice in regard to student support and
20 family engagement, and collaboration with family and
21 community organizations to monitor the implementation
22 of the policy;
23
24 (3) Incorporation of the recommendations of the working
25 group into the Department of Education's strategic
26 plan regarding improvement of two-way communication
27 with families and family and community stakeholder
28 organizations;

30 (4) Development of a common set of general practices
31 across the Department of Education to ensure that
32 families and schools have consistent expectations by
33 which to interact and communicate effectively;

35 (5) Coordination of resources and training for families
36 and schools to support family-school partnerships'
37 effective utilization of training teams that model the
38 family-school partnership concept through inclusion of
39 school, family, and community members; and

41 (6) Improvement of the effectiveness of the School Quality
42 Survey for Parents as a measure of school
43 accountability in improving family-school partnerships
44 by making the survey available in multiple languages



1 and adding demographic data to assess accurate
2 representation for each school's unique population;
3 now, therefore,
4

5 BE IT RESOLVED by the House of Representatives of the
6 Twenty-seventh Legislature of the State of Hawaii, Regular
7 Session of 2013, that the Board of Education and Department of
8 Education are requested to continue to collaborate with family
9 and community organizations to establish, implement, and monitor
10 statewide policy recommendations for family engagement in
11 Hawaii's public schools; and
12

13 BE IT FURTHER RESOLVED that the Board of Education and
14 Department of Education are requested to take the necessary
15 actions described above to fulfill the legislative intent of
16 S.C.R. 145 and S.C.R. 79; and
17

18 BE IT FURTHER RESOLVED that the Board of Education and
19 Department of Education are requested to report their findings
20 and recommendations regarding the facilitation of family-school
21 partnerships, including any proposed legislation and the status
22 of the actions described above to fulfill the legislative intent
23 of S.C.R. 145 and S.C.R. 79, to the Legislature no later than
24 twenty days prior to the Regular Session of 2014; and

26 BE IT FURTHER RESOLVED that certified copies of this
27 Resolution be transmitted to the Chairperson of the Board of
28 Education and the Superintendent of Education.
