
HOUSE RESOLUTION

REQUESTING THE CONTRACTORS LICENSE BOARD TO PREPARE A REPORT THAT EVALUATES EACH AUTOMATIC SPECIALTY LICENSE ISSUED TO "A" GENERAL ENGINEERING CONTRACTORS AND "B" GENERAL BUILDING CONTRACTORS.

1 WHEREAS, Hawaii's contractor licensing law, codified as
2 chapter 444, Hawaii Revised Statutes, is a consumer protection
3 statute intended to protect the public's health, safety, and
4 welfare when dealing with persons engaged in the construction
5 industry, and therefore requires a licensee to show experience
6 for each license obtained; and

7
8 WHEREAS, the Contractors License Board is the governing
9 board for contractors licensed in Hawaii; and

10
11 WHEREAS, the Contractors License Board issues "A" general
12 engineering contractor licenses, "B" general building contractor
13 licenses, and "C" specialty licenses; and

14
15 WHEREAS, the Contractors License Board has adopted
16 administrative rules that include various "C" specialty license
17 classifications with categories and descriptions of each
18 specialty license classification; and

19
20 WHEREAS, although payment of application, testing, and
21 license fees are required as part of the regulatory system for
22 contractors, the Contractors License Board automatically grants
23 seventeen additional "C" specialty licenses to licensed "A"
24 general engineering contractors and ten additional "C" specialty
25 licenses to licensed "B" general building contractors without
26 the need for further examination or additional payment of fees;

29 WHEREAS, S.B. No. 347, introduced during the Regular
30 Session of 2013, proposed to require licensed "A" general
31 engineering contractors and licensed "B" general building
32 contractors to pay additional fees and undergo further
33 examination prior to the issuance of additional "C" specialty
34 licenses; and

2 WHEREAS, a public hearing on S.B. No. 347 (2013) brought
3 forth groups opposing and supporting the measure; and
4

5 WHEREAS, testimony in opposition to S.B. No. 347 (2013)
6 cited the long-standing licensing process and potential negative
7 effects on licensed "A" and "B" general contractors; and
8

9 WHEREAS, testimony in support of S.B. No. 347 (2013)
10 questioned why a total of twenty-seven "C" specialty licenses
11 are issued without further examination and the payment of fees;
12 and
13

14 WHEREAS, past interpretations from the Contractors License
15 Board have determined that a "B" licensee may perform painting,
16 ceramic tile, and other specialty licensed work required on a
17 project without possession of those specific licenses; and
18

19 WHEREAS, in addition, the C-5 Cabinet, Millwork, and
20 Carpentry Remodeling and Repairs specialty classification is
21 automatically granted to "B" general building contractors; and
22

23 WHEREAS, subcontractors who have qualified for "C"
24 specialty licenses by demonstrating four years of supervisory
25 experience in the specific "C" specialty license categories are
26 frustrated that licensed "B" general building contractors
27 automatically qualify for the same "C" specialty license
28 classification without additional examinations and fees; and
29

30 WHEREAS, the Contractors License Board has not recently
31 reviewed the scope of the automatic "C" specialty licenses given
32 to "A" general engineering contractor licensees and "B" general
33 building contractor licensees; now, therefore,
34

35 BE IT RESOLVED by the House of Representatives of the
36 Twenty-seventh Legislature of the State of Hawaii, Regular
37 Session of 2013, that the Contractors License Board is requested
38 to prepare a report that evaluates each automatic specialty
39 license issued to "A" general engineering contractors and "B"
40 general building contractors; and

42 BE IT FURTHER RESOLVED that the Contractors License Board
43 is requested to include the following in the report:





- 1 (1) An identification of each specialty license that is
- 2 automatically granted to "A" general engineering
- 3 contractors and "B" general building contractors;
- 4
- 5 (2) A specific evaluation of the definition of a C-5
- 6 contractor, including whether this definition is too
- 7 broad, whether this definition includes an appropriate
- 8 balance between the work that is performed and the
- 9 experience necessary for a license, and a
- 10 determination of whether this definition should be
- 11 modified;
- 12
- 13 (3) An explanation and justification of why each specialty
- 14 license is automatically granted to "A" general
- 15 engineering contractors and "B" general building
- 16 contractors;
- 17
- 18 (4) Suggested amendments or modifications to the practice
- 19 of issuing specialty licenses, if appropriate; and
- 20
- 21 (5) A brief description of the process the Board used when
- 22 making its findings and recommendations in the report;
- 23 and
- 24

25 BE IT FURTHER RESOLVED that the Contractors License Board
 26 is requested to submit its report, including any recommendations
 27 for amendments to chapter 444, Hawaii Revised Statutes, and
 28 chapter 77, Hawaii Administrative Rules, to the Legislature no
 29 later than twenty days prior to the convening of the Regular
 30 Session of 2014; and

 32 BE IT FURTHER RESOLVED that certified copies of this
 33 Resolution be transmitted to Director of Commerce and Consumer
 34 Affairs and the Contractors License Board.
