## HOUSE RESOLUTION

URGING THE UNITED STATES CONGRESS TO GRANT FULL VOTING RIGHTS FOR RESIDENTS OF THE DISTRICT OF COLUMBIA.

WHEREAS, the United States Constitution provided for the 1 establishment of a federal district, known as Washington, 2 District of Columbia, and the residents of the federal district 3 were allowed to vote for members of the United States House of 4 Representatives from the time of incorporation in 1791 until 5 1801; and 6 7 WHEREAS, the passage of the Organic Act of 1801 placed the 8 District of Columbia under the exclusive authority of the United 9 States Congress and abolished residents' right to vote for 10 members of Congress and the President and Vice President of the 11 United States; and 12 13 WHEREAS, residents of the District of Columbia were granted 14 the right to vote for the President and Vice President through 15 passage of the Twenty-third Amendment to the United States 16 Constitution in 1961, which Hawaii was the first state to 17 ratify; and 18 19 WHEREAS, Congress has allowed the District of Columbia to 20 send a nonvoting delegate to the United States House of 21 Representatives since 1971; and 22 23 WHEREAS, Congress passed a constitutional amendment in 1978 24 to grant full voting rights to District of Columbia residents 25 and, although it was ratified by Hawaii and fifteen other 26 states, the proposed amendment was ultimately unsuccessful, thus 27 keeping the right to vote for congressional representation out 28 of reach for District of Columbia residents; and 29 30 WHEREAS, the District of Columbia has 601,723 residents, 31 which according to the 2010 census is comparable to the 32 populations of Wyoming (563,626), Vermont (625,741), North 33 34 Dakota (672,591), and Alaska (710,231); and 35

responsibilities of citizenship, including paying federal taxes, 2 serving on federal juries, and defending the United States as 3 members of the United States Armed Services in every war since 4 the War for Independence, yet they are denied full 5 representation in Congress; and 6 7 8 WHEREAS, the District of Columbia's economy is larger than 9 the economies of more than fifteen states; and 10 WHEREAS, the lack of federal representation severely limits 11 12 the ability of residents of the District of Columbia to influence legislation on matters directly affecting them, 13 including health, gun control, budgeting, taxes, and governance; 14 15 and 16 WHEREAS, the United States is a signatory to international 17 treaties calling for countries to grant full voting rights to 18 its adult citizens, including the International Covenant on 19 Civil and Political Rights, the Organization of American States' 20 American Declaration of the Rights and Duties of Man, and the 21 Convention on the Elimination of All Forms of Discrimination; 22 and 23 24 WHEREAS, in 2003, the Inter-American Commission on Human 25 Rights of the Organization of American States found the United 26 States to be in violation of international human rights law for 27 its disenfranchisement of District of Columbia residents; and 28 29 WHEREAS, Benjamin Cayetano, as Governor of the State of 30 Hawaii, recognized the fundamental right to representation of 31 District of Columbia residents and proclaimed August 2002 32 "District of Columbia Voting Rights Month"; and 33 34 WHEREAS, the White House has affixed the District of 35 36 Columbia's "Taxation Without Representation" license plates on the presidential limousine and other vehicles, stating that 37 President Obama "has seen first-hand how patently unfair it is 38 for working families in D.C. to work hard, raise children and 39 pay taxes, without having a vote in Congress. Attaching these 40 plates to the presidential vehicles demonstrates the President's 41 commitment to the principle of full representation for the 42 people of the District of Columbia and his willingness to fight 43

WHEREAS, District of Columbia residents share all the

for voting rights, home rule, and budget autonomy for the 1 district"; and 2 3 WHEREAS, in 2013, several measures have been introduced in 4 the United States Congress that provide for greater 5 representation and autonomy for the residents of the District of 6 Columbia; now, therefore, 7 8 9 BE IT RESOLVED by the House of Representatives of the Twenty-seventh Legislature of the State of Hawaii, Regular 10 Session of 2013, that members of the 113th United States 11 Congress are urged to enact federal legislation or propose a 12 constitutional amendment granting full voting rights to 13 residents of the District of Columbia; and 14 15 BE IT FURTHER RESOLVED that certified copies of this 16 17 Resolution be transmitted to the President of the United States, the Majority Leader of the United States Senate, the Speaker of 18 the United States House of Representatives, the District of 19 Columbia's congressional delegate, and members of Hawaii's 20 congressional delegation. 21 22 23 24
