
HOUSE RESOLUTION

URGING THE DEPARTMENT OF LAND AND NATURAL RESOURCES AND THE NATIONAL OCEANIC AND ATMOSPHERIC ADMINISTRATION TO MAKE AVAILABLE TO THE PUBLIC AN ANNUAL REPORT ON THE STATE'S ENDANGERED MARINE ANIMALS.

1 WHEREAS, marine and aquatic life is a vital and important
2 source of food sustenance and living for the people of Hawaii;
3 and
4

5 WHEREAS, the State has an interest in ensuring the survival
6 of the marine life in the State; and
7

8 WHEREAS, the Department of Land and Natural Resources has
9 partnered with the United States National Oceanic and
10 Atmospheric Administration to study marine life in the State,
11 including endangered marine life species; and
12

13 WHEREAS, currently, there is no information or an up-to-
14 date report of endangered marine life species in Hawaii that is
15 available to the public; and
16

17 WHEREAS, obtaining the most current and relevant
18 information regarding endangered marine life is important to
19 preserving the balance of the aquatic environment; and
20

21 WHEREAS, a publicly available current report on endangered
22 marine life species in Hawaii will enable the public to be more
23 informed of populations of endangered marine life species and,
24 thus, more respectful of their aquatic habitats; and
25

26 WHEREAS, a public, current list of endangered marine life
27 species would allow for more accurate and helpful fishing
28 regulations, thereby allowing for more flexible regulations for
29 non-endangered marine life species and stricter regulations on
30 species that are currently endangered; and

32 WHEREAS, an annual updated report from the United States
33 National Oceanic and Atmospheric Administration regarding the




1 State's current endangered marine life species would benefit the
2 fishers in the State and other commercial and recreational users
3 of the ocean; now, therefore,


5 BE IT RESOLVED by the House of Representatives of the

7 Session of 2013, that the United States National Oceanic and
8 Atmospheric Administration is requested to provide an annual
9 report of the State's endangered marine life to the Department
10 of Land and Natural Resources; and


12 BE IT FURTHER RESOLVED that the Department of Land and
