# A BILL FOR AN ACT

RELATING TO EMPLOYER UNION HEALTH BENEFITS TRUST FUND  
CONTRIBUTIONS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

- 1           SECTION 1. The purpose of this Act is to provide:
- 2           (1) Employer contribution amounts for plan years 2011-2012
- 3                     and 2012-2013 for Hawaii employer-union health benefits
- 4                     trust fund health benefit plan premiums for the employees
- 5                     of collective bargaining unit (10) and state officers and
- 6                     employees excluded from collective bargaining and
- 7                     belonging to the same compensation plans as those
- 8                     officers and employees within collective bargaining unit
- 9                     (10) pursuant to section 89-11(g), Hawaii Revised
- 10                    Statutes, due to an impasse in negotiations on issues
- 11                    involving the Hawaii employer-union health benefits trust
- 12                    fund; and
- 13           (2) Employer plan contributions of a specific dollar amount
- 14                     equivalent to fifty per cent of the premium rates
- 15                     established by the board of trustees of the Hawaii
- 16                     employer-union health benefits trust fund for the



1            respective health benefit plan plus fifty per cent of all  
2            administrative fees.

3            SECTION 2. For the employees of collective bargaining unit  
4            (10) and for state officers and employees excluded from collective  
5            bargaining who belong to the same compensation plans as those  
6            officers and employees within collective bargaining unit (10) for  
7            plan years 2011-2012 and 2012-2013, subject to the applicable  
8            provisions of chapters 87A and 89, Hawaii Revised Statutes, the  
9            employer monthly contributions to the Hawaii employer-union health  
10           benefits trust fund are as follows:

11           (1) The amounts paid by the employer in plan years 2011-2012  
12           and 2012-2013 for July 1, 2011, through December 31,  
13           2011, and January 1, 2012, through June 30, 2013, for  
14           each employee-beneficiary with no dependent-beneficiaries  
15           shall be:
