A BILL FOR AN ACT

RELATING TO TRANSPORTATION OF SCHOOL CHILDREN.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds and determines that
2	student transportation costs have escalated in recent years,
3	prompting the legislature to mandate comprehensive assessment
4	and reports relating to the transportation of school children.
5	The legislature finds and determines that the statutory
6	provisions governing the transportation of school children and
7	contracts for such transportation should be revised in a manner
8	that will enable the department of education to implement the
9	recommendations of the department's consultants in restructuring
10	the practices, policies, and procedures relating to requests for
11	proposal, thereby, providing greater flexibility in determining
12	the values as markets evolve while maintaining the integrity of
13	procurement through specifications in the contracting process.
14	In November 2012, the Student Bus Transportation Study
15	Final Report was received by the department of education from
16	its consultant, Management Partnership Services, Inc.,
17	confirming that student transportation costs have escalated
18	unacceptably in recent years. The final report cited statutory

1 compensation requirements as a constraint on contracting for bus 2 services. The report noted that statutory wording has the most 3 direct impact on system efficiencies as it establishes a floor 4 for bus driver salaries. 5 SECTION 2. Section 103-55, Hawaii Revised Statutes, is 6 amended by amending subsection (c) to read as follows: 7 This section shall apply to all contracts to perform 8 services in excess of \$25,000, including contracts to supply 9 ambulance service and janitorial service. **10** This section shall not apply to: 11 (1)Managerial, supervisory, or clerical personnel. **12** (2) Contracts for supplies, materials, or printing. 13 (3) Contracts for utility services. 14 (4)Contracts to perform personal services under 15 paragraphs (2), (3), (12), and (15) of section 76-16, 16 paragraphs (7), (8), and (9) of section 46-33, and 17 paragraphs (7), (8), and (12) of section 76-77. 18 Contracts for professional services. (5) **19** (6) Contracts to operate refreshment concessions in public 20 parks, [or] to provide food services to educational 21 institutions [-], or to provide transportation services

for school children.

JUSTIFICATION SHEET

DEPARTMENT:

Education

TITLE:

A BILL FOR AN ACT RELATING TO TRANSPORTATION OF SCHOOL CHILDREN.

PURPOSE:

To achieve the department's objective to control student transportation costs, by stimulating competitive bidding through the exemption of student transportation contacts form restrictions on labor costs, based in part on the report by Management Partnership Services, Inc.

MEANS:

Amend section 103-55(c), Hawaii Revised Statutes.

JUSTIFICATION:

The original purpose of 103-55 was to restrict competition on labor costs from consideration in selecting contractors performing services. Current law already excludes certain kinds of services from this restriction, such as contracts for refreshment concessions or to provide food services to schools. The purpose of this proposal is to extend the exclusion to school bus transportation service contracts, thus allowing competition among school bus transportation vendors on labor costs.

Impact on the public: Would enable school bus vendors to compete for student transportation contracts without constraint of complying with labor cost requirements, which would generate savings to be spent on other beneficial needs.
