## A BILL FOR AN ACT

RELATING TO CABLE TELEVISION.

	BE II ENACIED BY THE LEGISLATURE OF THE STATE OF HAWAII:
1	SECTION 1. The legislature finds that the Hawaiian
2	language movement has become a national and international leader
3	and model for indigenous language revitalization. The
4	legislature further finds that the media can have a very
5	important part in furthering the efforts to normalize the
6	Hawaiian language throughout Hawaii. The legislature strongly
7	supports the production and distribution of Hawaiian language
8	content on cable television but finds that additional guidance
9	is needed to determine the most appropriate method of providing
10	long-term sustainable funding for a cable television channel
11	dedicated to the Hawaiian language and perspective.
12	The purpose of this Act is to:
13	(1) Require the director of commerce and consumer affairs
14	to work with various interested stakeholders and

- assess the best method to ensure dedicated funding for the development of a Hawaiian television channel;
- (2) Require the director of commerce and consumer affairs to submit a report to the legislature no later than

, 1	twenty days prior to the convening of the regular
2	session of 2014; and
3	(3) Appropriate funds to 'Oiwi TV for the production and
4	distribution of Hawaiian language content on cable
5	television.
6	SECTION 2. (a) In light of the current cable television
7	franchise renewal, the director of commerce and consumer affairs
8	shall work with various interested stakeholders and assess the
9	best method to ensure dedicated funding for the development of a
10	Hawaiian television channel. The director shall also consider
11	the potential funding source for a Hawaiian television channel
12	to be included in the revenues derived from the cable television
13	franchise fees collected pursuant to chapter 440G, Hawaii
14	Revised Statutes.
15	(b) The director shall submit a report of findings and
16	recommendations regarding funding for the development of a
17	Hawaiian television channel, to the legislature no later than
18	twenty days prior to the convening of the regular session of
19	2014.
20	SECTION 3. There is appropriated out of the general
21	revenues of the State of Hawaii the sum of \$ or so
22	much thereof as may be necessary for fiscal year 2013-2014 to

- 1 provide funding as a grant pursuant to chapter 42F, Hawaii
- 2 Revised Statutes, to 'Oiwi TV for the production and distribution
- 3 of Hawaiian language content on cable television.
- 4 The sum appropriated shall be expended by the department of
- 5 commerce and consumer affairs for the purposes of this Act.
- 6 SECTION 4. This Act shall take effect on July 1, 2013.
