BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

3	and to re	ad as follows:

6	SECT	ION 2. Section 707-716, Hawaii Revised Statutes, is
7	amended b	y amending subsection (1) to read as follows:
8	"(1)	A person commits the offense of terroristic
9	threateni	ng in the first degree if the person commits
10	terrorist	ic threatening:
11	(a)	By threatening another person on more than one
12		occasion for the same or a similar purpose;
13	(b)	By threats made in a common scheme against different
14		persons;
15	(C)	Against a public servant arising out of the
16		performance of the public servant's official duties.
17		For the purposes of this paragraph, "public servant"
18		includes but is not limited to an educational worker.

1		"Educational worker" has the same meaning as defined
2		in section 707-711;
3	(d)	Against any emergency medical services provider who is
4		engaged in the performance of duty. For purposes of
5		this paragraph, "emergency medical services provider"
6		means emergency medical services personnel, as defined
7		in section 321-222, and physicians, physician's
8		assistants, nurses, nurse practitioners, certified
9		registered nurse anesthetists, respiratory therapists,
10		laboratory technicians, radiology technicians, and
11		social workers, providing services in the emergency
12		room of a hospital;
13	(e)	With the use of a dangerous instrument $[+]$ or \underline{a}
14		simulated firearm; or
15	(f)	By threatening a person who:
16		(i) The defendant has been restrained from, by order
17		of any court, including an ex parte order,
18		contacting, threatening, or physically abusing
19		pursuant to chapter 586; or
20		(ii) Is being protected by a police officer ordering
21		the defendant to leave the premises of that

1	protected person pursuant to section 709-906(4),
2	during the effective period of that order."
3	SECTION 3. Section 708-800, Hawaii Revised Statutes, is
4	amended by adding a new definition to be appropriately inserted
5	and to read as follows:
6	""Simulated firearm" means any object that resembles a
7	firearm or is used or brandished as a firearm."
8	SECTION 4. Section 708-840, Hawaii Revised Statutes, is
9	amended by amending subsection (1) to read as follows:
10	"(1) A person commits the offense of robbery in the first
11	degree if, in the course of committing theft or non-consensual
12	taking of a motor vehicle:
13	(a) The person attempts to kill another or intentionally
14	or knowingly inflicts or attempts to inflict serious
15	bodily injury upon another;
16	(b) The person is armed with a dangerous instrument or a
17	simulated firearm and:
18	(i) The person uses force against the person of
19	anyone present with intent to overcome that
20	person's physical resistance or physical power of
21	resistance; or

1		(ii) The person threatens the imminent use of force
2		against the person of anyone present with intent
3		to compel acquiescence to the taking of or
4		escaping with the property;
5	(c)	The person uses force against the person of anyone
6		present with the intent to overcome that person's
7		physical resistance or physical power of resistance
8		during the time of a civil defense emergency
9		proclaimed by the governor pursuant to chapter 128,
10	•	within the area covered by the civil defense emergency
11		or during the period of disaster relief under chapter
12		127; or
13	(d)	The person threatens the imminent use of force against
14		the person of anyone present with intent to compel
15		acquiescence to the taking of or escaping with the
16		property during the time of a civil defense emergency
17		proclaimed by the governor pursuant to chapter 128,
18		within the area covered by the civil defense emergency
19		or during the period of disaster relief under chapter
20		127."
