A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF PUBLIC SAFETY SHERIFF DIVISION ENTERING INTO AGREEMENTS TO PROVIDE SECURITY AT PUBLIC HOUSING PROJECTS OPERATED BY THE PUBLIC HOUSING AUTHORITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 356D-9, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows:

- (1) Obtain the aid and cooperation of other government agencies in the planning, construction, and operation of public housing projects and enter into agreements and arrangements as it deems advisable to obtain aid and cooperation;
- (2) Arrange or enter into agreements with any government agency for the acquisition by that agency of property, options, or property rights; for the furnishing, installing, opening, or closing of streets, roads, alleys, sidewalks, or other places; for the furnishing of property, services, parks, sewage, water, and other facilities in connection with public housing projects; or for the changing of the map of a political

1		subdivision or the planning, replanning, zoning, or
2		rezoning of any part of a political subdivision;
3	(3)	Procure insurance or guarantees from any government
4		agency for the payment of any debts or parts thereof
5		incurred by the authority, including the power to pay
6		premiums on any such insurance; [and]
7	(4)	Agree to make payments to the state or county
8		government, if the government is authorized to accept
9		payments, as the authority deems consistent with the
10		maintenance of the character of public housing
11		projects or the purposes of this chapter [-]; and
12	<u>(5)</u>	Arrange or enter into agreements with the department
13	•	of public safety to obtain the aid and cooperation of
14		the department's sheriff division for the security of
15		the residents, staff, buildings, and lands of the
16		authority. The authority may do any and all things
17		necessary or convenient under this subsection to
18		ensure that its security needs are satisfied by the
19		sheriff division, including but not limited to the:
20		(A) Provision of appropriate buildings, dwelling
21		units, or structures for the use of the sheriff

7		equipment, furniture, and supplies."

10	SECTION 3	. This Act shall take effect on July 1, 2050.
