A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that food safety is a
- 2 significant concern for residents in Hawaii and the United
- 3 States. However, the issue of food safety cannot be addressed
- 4 in a vacuum and involves collaboration amongst farmers, large
- 5 and small; consumers; and various state and federal agencies.
- 6 The federal Food Safety Modernization Act was enacted with the
- 7 express purpose of addressing food safety and agriculture
- 8 issues. The United States Food and Drug Administration, in
- 9 partnership with the United States Department of Agriculture, is
- 10 crafting the necessary rules to implement the Food Safety
- 11 Modernization Act. While the federal regulations for the Food
- 12 Safety Modernization Act have not been finalized, the State of
- 13 Hawaii intends to proactively examine good agricultural
- 14 practices that will improve the overall safety of the food the
- 15 residents of Hawaii grow and eat and provide farmers with rules
- 16 that address locally-based concerns.
- 17 United States Deputy Secretary of Agriculture, Kathleen
- 18 Merrigan, partnered with FamilyFarmed.org to create an online SB326 HD1 HMS 2013-2754-1



- 1 tool that enables produce growers to create customized food
- 2 safety plans. The use of this tool is voluntary but would
- 3 provide growers the ability to assess risks specific to their
- 4 farms and suggest practices to mitigate those risks. In a
- 5 similar fashion, the State of Hawaii intends to work with
- 6 agriculture producers to develop preventative measures that will
- 7 address inherent risks involved in current farming and ranching
- 8 practices. The preventative measures will address practices
- 9 throughout the food supply system, from the foods' origin on the
- 10 farm to its ultimate destination, the wholesaler or retailer.
- In addressing good agricultural practices and preventative
- 12 measures from farm to wholesaler, one vital component to address
- 13 is integrated pest management. Safe practices on farms cannot
- 14 be addressed without addressing the proper use of pesticides. A
- 15 good integrated pest management system incorporates proper
- 16 sanitation practices, physical barriers, bio-control, and use of
- 17 pesticides when necessary.
- 18 The purpose of this Act is to mitigate health and food
- 19 safety risks involved in food production by establishing a task
- 20 force to identify and develop good agricultural practices and
- 21 preventative measure guidelines to ensure safe food throughout
- 22 the farm-to-consumer food supply system.

2	practices	task force to identify and develop good agricultural
3	practices	and preventative measure guidelines in the food supply
4	system to	improve the overall safety of locally grown food.
5	(b)	The chairperson of the board of agriculture or the
6	chairpers	on's designee shall serve as chair of the task force.
7	(c)	Notwithstanding section 26-34, Hawaii Revised
8	Statutes,	the task force shall be composed of:
9	(1)	The director of health, or the director's designee;
10	(2)	The dean of the University of Hawaii college of
11		tropical agriculture and human resources or the dean's
12		designee;
13	(3)	The chair of the senate committee on agriculture;
14	(4)	The chair of the house of representatives committee on
15		agriculture;
16	(5)	The president of the Hawaii Farm Bureau Federation or
17		the president's designee;
18	(6)	The president of the Hawaii Farmer's Union United or
19		the president's designee;
20	(7)	Four representatives from agricultural producers
21		statewide selected by the governor, at least one of
22		which represents the interests of organic farmers; and

1	(8)	One representative appointed by the governor from each
2		of the following industries, who shall be requested to
3		serve:
4		(A) Wholesale distribution;
5		(B) Manufacturing;
6		(C) Retail;
7		(D) Hotels;
8		(E) Restaurants; and
9		(F) Farmers' markets.
10	(d)	The food safety task force shall:
11	(1)	Identify and develop good agricultural practices and
12		preventative measure guidelines for agricultural
13		producers to follow, in order to mitigate food safety
14		risks that may arise throughout the farm-to-consumer
15		food supply system; and
16	(2)	Research other state, county, and organizational
17		policies and suggested best practices related to food
18		safety that may arise in the farm-to-consumer supply
19		system.
20	(e)	The task force shall submit a report of its findings,
21	recommend	lations, and proposed legislation to the legislature, no

- 1 later than twenty days prior to the convening of the regular
- 2 session of 2014, and shall be dissolved on July 1, 2014.
- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so much
- 5 thereof as may be necessary for fiscal year 2013-2014 for
- 6 administrative costs associated with the good agricultural
- 7 practices task force to include statewide meetings. The
- 8 appropriation made for the purposes authorized under this
- 9 section shall not lapse at the end of the fiscal year for which
- 10 the appropriations are made; provided that any balance of any
- 11 appropriation that is not encumbered as of June 30, 2015, shall
- 12 lapse as of that date.
- 13 The sum appropriated shall be expended by the department of
- 14 agriculture for the purposes of this Act.
- 15 SECTION 4. This Act shall take effect on July 1, 2050.
