A BILL FOR AN ACT

RELATING TO HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 2 | SECTION 1. The legislature finds that homelessness |
| 3 | continues to be one of the State's most significant and |
| 4 | challenging social problems. The legislature further finds that |
| 5 | according to a recent report, fourteen thousand two hundred |
| 6 | homeless individuals were served through shelter and outreach |
| 7 | programs in fiscal year 2011. Of these individuals, nine |
| 8 | thousand seven hundred eighty-one resided in the city and county |
| 9 | of Honolulu. The legislature also finds that homeless service |
| 10 | providers estimate that six thousand homeless people in the |
| 11 | State need shelter each night. |
| 12 | The legislature additionally finds that homelessness is a |
| 13 | complex issue that requires continuous resources and coordinated |
| 14 | efforts at all levels. The legislature also finds that homeless |
| 15 | persons face a myriad of issues, including mental illness, |
| 16 | substance abuse, loss of employment and income, and a lack of |
| 17 | affordable housing. Appropriate funding for programs and |
| 18 | services tailored to address these issues is essential. |

- 1 The purpose of this part is to better assist individuals
- 2 facing or experiencing homelessness by funding various homeless
- 3 and housing programs.
- 4 SECTION 2. There is appropriated out of the general
- 5 revenues of the State of Hawaii the sum of \$ or so
- 6 much thereof as may be necessary for fiscal year 2013-2014 and
- 7 the same sum or so much thereof as may be necessary for fiscal
- 8 year 2014-2015 for the homeless programs office of the
- 9 department of human services to assist homeless and at-risk
- 10 homeless individuals and families with housing placement,
- 11 health, education, employment, and other support services.
- 12 The sums appropriated shall be expended by the department
- 13 of human services for the purposes of this part.
- 14 SECTION 3. The director of finance is authorized to issue

| 3 | United States Housing and Urban Development's homelessness |
| 4 | prevention and rapid re-housing program was to provide |
| 5 | economically distressed households and individuals with |
| 6 | financial and other assistance to prevent them from becoming |
| 7 | homeless and help those who are experiencing homelessness to be |
| 8 | quickly re-housed and stabilized. The funds under this program |
| 9 | were intended to target individuals and families who would be |

- 7 2014-2015 for the homelessness prevention and rapid re-housing
- 8 program.
- 9 The sums appropriated shall be expended by the department
- 10 of human services for the purposes of this part.
- 11 PART V
- 12 SECTION 14. The shelter plus care program of the United
- 13 States Department of Housing and Urban Development provides
- 14 rental assistance in connection with supportive services. The
- 15 program provides a variety of permanent housing choices,
- 16 accompanied by a range of supportive services funded through
- 17 other sources. The program assists hard-to-serve homeless
- 18 individuals with disabilities and their families. These
- 19 individuals primarily include those with serious mental illness,
- 20 chronic problems with alcohol and drugs, and HIV, AIDS, or
- 21 related diseases.

1 There are four components to the shelter plus care program: 2 single room occupancy component - moderate rehabilitation for 3 single-room occupancy dwellings; sponsor-based rental assistance 4 component; project-based rental assistance component; and 5 tenant-based rental assistance component. Under all components, 6 supportive services must be available to meet the needs of participants. Similar to many other federal programs, the 7 shelter plus care program has a match requirement. Applicants 8 9 must match the aggregate amount of shelter plus care rental **10** assistance with supportive services. This ensures that 11 appropriate and timely services will be available to meet the 12 needs of individual participants. 13 The purpose of this part is to provide matching funds for 14 the shelter plus care program. 15 SECTION 15. There is appropriated out of the general 16 revenues of the State of Hawaii the sum of \$ or so much 17 thereof as may be necessary for fiscal year 2013-2014 and the same sum or so much thereof as may be necessary for fiscal year 18 19 2014-2015 for matching funds for the shelter plus care program 20 of the United States Department of Housing and Urban

Development.

Homelessness; Housing; Appropriation

Description:

Appropriates unspecified funds to the homeless programs office of the department of human services and the rental housing trust fund. Appropriates unspecified funds to the department of health for substance abuse treatment, mental health support services, and clean and sober housing services. Appropriates funds for a rental assistance program, also known as a shallow subsidy program. Appropriates funds to the Hawaii public housing authority to continue to administer housing first programs for chronically homeless individuals and to reestablish the homeless prevention and rapid re-housing program. Appropriates funds out of the rental housing trust fund. Appropriates matching funds for the federal shelter plus care program to provide rental assistance in connection with supportive services.
