
A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that while the candidate
2 advisory council for the board of regents of the University of
3 Hawaii has nominated many outstanding appointees to the board,
4 important concerns have been raised as to the selection process.
5 Since the passage of Act 56, Session Laws of Hawaii 2007, to
6 implement the amendments to article X, section 6 of the state
7 constitution, a number of issues have arisen from the new method
8 of regent selection that hampered the work of the regents
9 candidate advisory council and led to questions regarding the
10 final selection of appointees during the senate confirmation
11 process.

12 The purpose of this Act is to reconstitute the form and
13 processes of the candidate advisory council to increase the
14 governor's ability to appoint qualified individuals to serve as
15 members of the board of regents and effectively lead the
16 University of Hawaii.



1 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
2 amended by adding a new section to be appropriately designated
3 and to read as follows:

4 "§304A- Candidate advisory council for the board of
5 regents of the University of Hawaii. (a) The candidate
6 advisory council for the board of regents of the University of
7 Hawaii shall recruit, rate, and present to the governor
8 qualified candidates for nomination to a vacant seat on the
9 board of regents. The candidate advisory council shall be
10 temporarily placed in the office of the governor for
11 administrative purposes.

12 (b) The candidate advisory council shall:

13 (1) Develop and implement a fair and independent procedure
14 for rating candidates to serve on the board of
15 regents;

16 (2) Require candidates and members of their immediate
17 family to disclose any existing or anticipated
18 contracts or financial transactions with the
19 University of Hawaii, and family relationships with
20 University of Hawaii employees;

21 (3) Actively solicit and accept applications from
22 potential candidates;



1 (4) Rate candidates for the board of regents on their
2 backgrounds, experience, and potential for discharging
3 the responsibilities of a member of the board of
4 regents, based upon the qualifications imposed by the
5 state constitution; and

6 (5) Present a list of at least three candidates to the
7 governor for nomination and appointment for each
8 vacant seat on the board of regents of the University
9 of Hawaii.

10 (c) The candidate advisory council shall initiate the
11 recruitment and rating of candidates for each vacancy on the
12 board of regents within:

13 (1) Thirty days of a vacancy; or

14 (2) At least one hundred twenty days prior to the
15 expiration of a regent's term.

16 (d) To provide continuity for the board of regents, the
17 governor may recommend to the candidate advisory council the
18 reappointment of a board of regents member, subject to senate
19 confirmation.

20 (e) The candidate advisory council shall consist of seven
21 members, to be appointed by the governor without regard to
22 section 26-34, and one non-voting ex officio member who shall be



1 the most recent emeritus chair of the board of regents; provided
2 that:

3 (1) One member shall be a student of the university who
4 has been enrolled as a full-time student for at least
5 three consecutive semesters; and

6 (2) The governor is encouraged to appoint university
7 faculty and staff to the candidate advisory council.

8 Appointees to the candidate advisory council shall have a
9 general understanding of the purposes of higher education, the
10 mission and strategic goals of the University of Hawaii system,
11 and the role and responsibilities of the board of regents.

12 Appointees shall be individuals who are widely viewed as having
13 placed the broad public interest ahead of special interests, who
14 are respected by the community, and who are highly qualified to
15 recruit and rate candidates for the governor's consideration.

16 (f) Each member of the candidate advisory council shall
17 serve for the duration of the term of the governor by whom the
18 member was appointed.

19 (g) The candidate advisory council shall operate in a
20 wholly nonpartisan manner. No member of the candidate advisory
21 council shall run for or hold any elected office of the State or
22 its political subdivisions. A member of the candidate advisory



1 council shall resign from the candidate advisory council prior
2 to filing nomination papers for an elected office of the State
3 or its political subdivisions.

4 (h) The governor shall appoint the chairperson of the
5 candidate advisory council. A majority of the members to which
6 the candidate advisory council is entitled shall constitute a
7 quorum to do business. The concurrence of a majority of all the
8 members to which the candidate advisory council is entitled
9 shall be necessary to make any action of the candidate advisory
10 council valid.

11 (i) Members of the candidate advisory council shall serve
12 without compensation but shall be reimbursed for expenses,
13 including travel, board, and lodging expenses, necessary for the
14 performance of their duties."

15 SECTION 3. Section 304A-104, Hawaii Revised Statutes, is
16 amended to read as follows:

17 **"§304A-104 Regents; appointment; tenure; qualifications;**
18 **meetings.** (a) The affairs of the university shall be under the
19 general management and control of the board of regents
20 [consisting]. The board shall consist of fifteen members who
21 shall be appointed [and] by the governor from lists of qualified
22 candidates presented to the governor by the candidate advisory



1 council and shall be confirmed by the senate; provided that if
2 the list of qualified candidates includes less than three
3 candidates at any time during the nomination and confirmation
4 process, the governor may request that the candidate advisory
5 council reopen recruitment for qualified candidates. Members
6 may be removed by the governor. Except as otherwise provided by
7 law, state officers shall be eligible for appointment and
8 membership. The term of each member shall be five years, except
9 as provided for the initial appointment in section 26-11;
10 provided that the term of the student member shall be two years.
11 Every member may serve beyond the expiration date of the
12 member's term of appointment until the member's successor has
13 been appointed by the governor and confirmed by the senate in
14 accordance with article X, section 6 of the Hawaii constitution.
15 Members shall serve no more than two consecutive five-year
16 terms; provided that the members who are initially appointed to
17 terms of two years or less pursuant to section 26-11(a) may be
18 reappointed to two ensuing five-year terms. If a member is to
19 be appointed to a second term of five years, the senate shall
20 consider the question of whether to reconfirm the member at
21 least one hundred twenty days prior to the conclusion of a
22 member's first five-year term; provided that if the senate is



1 not in session within one hundred twenty days prior to the
2 conclusion of the member's first five-year term, the member
3 shall continue to serve until the senate convenes for the next
4 regular session or the next special session for which the senate
5 is authorized to consider the question of reconfirmation.

6 (b) In determining whether to confirm the governor's
7 nominee to the board of regents, the senate shall consider the
8 combination of abilities, breadth of experiences, and
9 characteristics of the board of regents, as a whole, that will
10 best serve the diverse interests and needs of the students of
11 the university system and assist the university system in
12 achieving its strategic goals and performance indicators. The
13 senate shall consider such factors as whether the board reflects
14 the diversity of the student population, the various counties of
15 the State, and a broad representation of higher education-
16 related stakeholders.

17 ~~[(b)]~~ (c) At a meeting preceding July 1 of each year, the
18 board of regents shall elect a chairperson and up to two vice-
19 chairpersons whose terms shall be from July 1 to June 30 of the
20 next year or thereafter until their successors are elected. The
21 board shall appoint a secretary, who shall not be a member of
22 the board. The president of the university shall act as



1 executive officer of the board. A majority of the board of
2 regents shall constitute a quorum to conduct business, and the
3 concurrence of a majority of all the members to which the board
4 of regents is entitled shall be necessary to make any action of
5 the board of regents valid. The board shall meet at least ten
6 times annually and, from time to time, may meet in each of the
7 counties of Hawaii, Maui, and Kauai.

8 ~~[(e)]~~ (d) The governor shall notify the ~~[regents]~~
9 candidate advisory council for the board of regents of the
10 University of Hawaii in writing within ten days of receiving
11 notification that a member of the board of regents is resigning,
12 has died, or is being removed by the governor.

13 ~~[(d)]~~ (e) The members of the board of regents shall serve
14 without pay but shall be entitled to their travel expenses
15 within the State when attending meetings of the board or when
16 actually engaged in business relating to the work of the board."

17 SECTION 4. Section 304A-104.5, Hawaii Revised Statutes, is
18 repealed.

19 ~~["§304A-104.5 Regents candidate advisory council for the~~

21 ~~established the regents candidate advisory council for the board~~
22 ~~of regents of the University of Hawaii to present to the~~

17 ~~The regents candidate advisory council shall be deemed to have~~
18 ~~fulfilled its obligation under this section upon presentation of~~
19 ~~the names of the minimum number of candidates required to be~~
20 ~~presented for each seat or seats on the board of regents.~~

21 ~~(c) When there are multiple seats vacant within the same~~
22 ~~county or within the at large membership, the regents candidate~~



1 ~~advisory council shall present candidates for seats on the board~~
2 ~~of regents to the governor as follows:~~

3 ~~(1) For two seats from the same county or two at large~~
4 ~~seats, no fewer than four and no more than six~~
5 ~~candidates;~~

6 ~~(2) For three seats from the same county, no fewer than~~
7 ~~five and no more than eight candidates; and~~

8 ~~(3) For more than three seats, the regents candidate~~
9 ~~advisory council shall determine appropriate minimum~~
10 ~~numbers of candidates, which shall provide for at~~
11 ~~least three candidates for the final seat, and maximum~~
12 ~~numbers of candidates.~~

13 ~~(d) In making its presentations, the regents candidate~~
14 ~~advisory council shall:~~

15 ~~(1) Develop a statement that includes the selection~~
16 ~~criteria to be applied and a description of the~~
17 ~~responsibilities and duties of a member of the board~~
18 ~~of regents and distribute this statement to potential~~
19 ~~candidates;~~

20 ~~(2) Screen and qualify candidates for each position on the~~
21 ~~board of regents based on their background;~~

2 ~~responsibilities of a member of the board of regents,~~
3 ~~(3) Publicly advertise pending vacancies and actively~~
4 ~~solicit and accept applications from potential~~
5 ~~candidates,~~
6 ~~(4) Develop and implement a fair, independent, and~~
7 ~~nonpartisan procedure for selecting candidates to~~
8 ~~serve on the board of regents,~~
9 ~~(5) Ensure student involvement by establishing a student~~
10 ~~advisory group composed of:~~
11 ~~(A) The senior student affairs officer of the~~
12 ~~University of Hawaii system,~~
13 ~~(B) No fewer than three student representatives from~~
14 ~~the University of Hawaii student caucus who shall~~
15 ~~represent, to the maximum extent possible, the~~
16 ~~interests of the various University of Hawaii~~

18 ~~(C) No fewer than three student life advisors who~~
19 ~~shall represent, to the maximum extent possible,~~

2 ~~advisory council to recruit and evaluate candidates~~
3 ~~for the student member of the board of regents and~~

6 ~~applying for the position; and~~

7 ~~(6) Require each candidate to disclose any existing or~~
8 ~~anticipated contracts with the University of Hawaii or~~
9 ~~any existing or anticipated financial transactions~~
10 ~~with the University of Hawaii.~~

11 ~~Upon submission of the names of candidates to the governor, the~~
12 ~~regents candidate advisory council shall make available the~~
13 ~~names of candidates to the public through the University of~~
14 ~~Hawaii.~~

15 ~~(e) For each board seat to be filled, the governor shall~~
16 ~~select one nominee from among the candidates submitted by the~~
17 ~~regents candidate advisory council.~~

18 ~~(f) The regents candidate advisory council shall consist~~
19 ~~of seven members to be appointed without regard to section 26-34~~
20 ~~as follows:~~

21 ~~(1) One member shall be appointed by the president of the~~
22 ~~senate;~~



- 1 ~~(2) One member shall be appointed by the speaker of the~~
2 ~~house of representatives;~~
- 3 ~~(3) One member shall be appointed by the governor;~~
- 4 ~~(4) One member shall be appointed by one of the co chairs~~
5 ~~of the All Campus Council of Faculty Senate Chairs of~~
6 ~~the University of Hawaii. A person may not be~~
7 ~~appointed as a member of the regents candidate~~
8 ~~advisory council under this paragraph, if within the~~

3 ~~provided that members appointed under paragraphs (4) to (7)~~
4 ~~shall be selected from the general public and may include~~

8 ~~The regents candidate advisory council shall be selected in~~
9 ~~a wholly nonpartisan manner. Appointees to the regents~~
10 ~~candidate advisory council shall have a general understanding of~~
11 ~~the purposes of higher education, the mission of the University~~
12 ~~of Hawaii system, and the responsibilities of the board of~~
13 ~~regents. Appointees shall be individuals who are widely viewed~~
14 ~~as having placed the broad public interest ahead of special~~
15 ~~interests, having achieved a high level of prominence in their~~
16 ~~respective professions, and being respected members of the~~
17 ~~community.~~

18 ~~(g) Members of the regents candidate advisory council~~
19 ~~shall serve four year terms.~~

20 ~~(h) If a vacancy occurs, a successor shall be appointed in~~
21 ~~the same manner and subject to the same qualifications as the~~
22 ~~person's predecessor. The person appointed to fill a vacancy~~



1 ~~shall serve for the remainder of the term of the person's~~
2 ~~predecessor.~~

3 ~~(i) The regents candidate advisory council shall operate~~
4 ~~in a wholly nonpartisan manner. No individual, while a member~~
5 ~~of the regents candidate advisory council, shall run for or hold~~
6 ~~any elected office under the United States or the State or any~~
7 ~~of its political subdivisions.~~

8 ~~(j) The members of the regents candidate advisory council~~
9 ~~shall choose a chairperson from among themselves. A majority of~~
10 ~~all the members to which the regents candidate advisory council~~
11 ~~is entitled shall constitute a quorum to conduct business. The~~
12 ~~concurrence of a majority of all the members to which the~~
13 ~~regents candidate advisory council is entitled shall be~~

21 SECTION 5. The members of the candidate advisory council
22 for the board of regents of the University of Hawaii who are



1 serving on the effective date of this Act shall serve until the
2 council is reconstituted by the governor's appointment of seven
3 members to the council pursuant to this Act, at which time the
4 members of the regents candidate advisory council who are
5 serving on the effective date of this Act shall be discharged
6 from office and the members appointed directly by the governor
7 pursuant to this Act shall begin their service. The governor
8 shall appoint seven members to the council no later than
9 days after the effective date of this Act.

10 SECTION 6. Statutory material to be repealed is bracketed
11 and stricken. New statutory material is underscored.

12 SECTION 7. This Act shall take effect upon its approval.
