A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that while the candidate
- 2 advisory council for the board of regents of the University of
- 3 Hawaii has nominated many outstanding appointees to the board,
- 4 important concerns have been raised as to the selection process.
- 5 Since the passage of Act 56, Session Laws of Hawaii 2007, to
- 6 implement the amendments to article X, section 6 of the state
- 7 constitution, a number of issues have arisen from the new method
- 8 of regent selection that hampered the work of the regents
- 9 candidate advisory council and led to questions regarding the
- 10 final selection of appointees during the senate confirmation
- 11 process.
- The purpose of this Act is to reconstitute the form and
- 13 processes of the candidate advisory council to increase the
- 14 governor's ability to appoint qualified individuals to serve as
- 15 members of the board of regents and effectively lead the
- 16 University of Hawaii.

1	SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§304A- Candidate advisory council for the board of
5	regents of the University of Hawaii. (a) The candidate
6	advisory council for the board of regents of the University of
7	Hawaii shall recruit, rate, and present to the governor
8	qualified candidates for nomination to a vacant seat on the
9	board of regents. The candidate advisory council shall be
10	temporarily placed in the office of the governor for
11	administrative purposes.
12	(b) The candidate advisory council shall:
13	(1) Develop and implement a fair and independent procedure
14	for rating candidates to serve on the board of
15	regents;
16	(2) Require candidates and members of their immediate
17	family to disclose any existing or anticipated
18	contracts or financial transactions with the
19	University of Hawaii and family relationships with
20	University of Hawaii employees;
21	(3) Actively solicit and accept applications from
22	<pre>potential candidates;</pre>

1	(4)	Rate candidates for the board of regents on their
2		background, experience, and potential for discharging
3		the responsibilities of a member of the board of
4		regents, based upon the qualifications imposed by the
5		state constitution; and
6	(5)	Present a list of at least three candidates to the
7		governor for nomination and appointment for each
8		vacant seat on the board of regents of the University
9		of Hawaii.
10	(c)	The candidate advisory council shall initiate the
11	recruitme	nt and rating of candidates for each vacancy on the
12	board of	regents within:
13	(1)	Thirty days of a vacancy; or
14	(2)	At least one hundred twenty days prior to the
15		expiration of a regent's term.
16	(d)	To provide continuity for the board of regents, the
17	governor	may recommend to the candidate advisory council the
18	reappoint	ment of a board of regents member, subject to senate
19	confirmat	ion.
20	(e)	The candidate advisory council shall consist of seven
21	members,	to be appointed by the governor without regard to
22	section 2	6-34, and one non-voting ex officio member who shall be

1	the most recent emeritus chair of the board of regents; provided
2	that:
3	(1) One member shall be a student of the university who
4	has been enrolled as a full-time student for at least
5	three consecutive semesters; and
6	(2) The governor is encouraged to appoint university
7	faculty and staff to the candidate advisory council.
8	Appointees to the candidate advisory council shall have a
9	general understanding of the purposes of higher education, the
10	mission and strategic goals of the University of Hawaii system,
11	and the role and responsibilities of the board of regents.
12	Appointees shall be individuals who are widely viewed as having
13	placed the broad public interest ahead of special interests, are
14	respected by the community, and are highly qualified to recruit
15	and rate candidates for the governor's consideration.
16	(f) Each member of the candidate advisory council shall
17	serve for the duration of the term of the governor by whom the
18	member was appointed.
19	(g) The candidate advisory council shall operate in a
20	wholly nonpartisan manner. No member of the candidate advisory
21	council shall run for or hold any elected office of the State or
22	its political subdivisions. A member of the candidate advisory

- 1 council shall resign from the candidate advisory council prior
- 2 to filing nomination papers for an elected office of the State
- 3 or its political subdivisions.
- 4 (h) The governor shall appoint the chairperson of the
- 5 candidate advisory council. A majority of the members to which
- 6 the candidate advisory council is entitled shall constitute a
- 7 guorum to do business. The concurrence of a majority of all the
- 8 members to which the candidate advisory council is entitled
- 9 shall be necessary to make any action of the candidate advisory
- 10 council valid.
- 11 (i) Members of the candidate advisory council shall serve
- 12 without compensation but shall be reimbursed for expenses,
- 13 including travel expenses, necessary for the performance of
- 14 their duties."
- 15 SECTION 3. Section 304A-104, Hawaii Revised Statutes, is
- 16 amended to read as follows:
- 17 "\$304A-104 Regents; appointment; tenure; qualifications;
- 18 meetings. (a) The affairs of the university shall be under the
- 19 general management and control of the board of regents
- 20 [consisting]. The board shall consist of fifteen members who
- 21 shall be appointed [and] by the governor from lists of qualified
- 22 candidates presented to the governor by the candidate advisory

    council, pursuant to section 304A- , and shall be confirmed by
    the senate; provided that if the list of qualified candidates
2
    includes less than three candidates at any time during the
3
    nomination and confirmation process, the governor may request
4
    that the candidate advisory council reopen recruitment for
5
    qualified candidates. Members may be removed by the governor.
6
    Except as otherwise provided by law, state officers shall be
7
    eligible for appointment and membership.
8
         The term of each member shall be five years, except as
9
    provided for the initial appointment in section 26-11; provided
10
    that the term of the student member shall be two years. Every
11
    member may serve beyond the expiration date of the member's term
12
    of appointment until the member's successor has been appointed
13
    by the governor and confirmed by the senate in accordance with
14
    article X, section 6 of the Hawaii constitution. Members shall
15
16
    serve no more than two consecutive five-year terms; provided
    that the members who are initially appointed to terms of two
17
    years or less pursuant to section 26-11(a) may be reappointed to
18

    two ensuing five-year terms. If a member is to be appointed to
    a second term of five years, the senate shall consider the
20
    question of whether to reconfirm the member at least one hundred
21
    twenty days prior to the conclusion of a member's first five-

- 1 year term; provided that if the senate is not in session within
- 2 one hundred twenty days prior to the conclusion of the member's
- 3 first five-year term, the member shall continue to serve until
- 4 the senate convenes for the next regular session or the next
- 5 special session for which the senate is authorized to consider
- 6 the question of reconfirmation.
- 7 (b) In determining whether to confirm the governor's
- 8 nominee to the board of regents, the senate shall consider the
- 9 combination of abilities, breadth of experiences, and
- 10 characteristics of the board of regents, as a whole, that will
- 11 best serve the diverse interests and needs of the students of
- 12 the university system and assist the university system in
- 13 achieving its strategic goals and performance indicators. The
- 14 senate shall consider whether the board reflects the diversity
- 15 of the student population, the various counties of the State,
- 16 and a broad representation of higher education-related
- 17 stakeholders.
- 18 $[\frac{b}{a}]$ (c) At a meeting preceding July 1 of each year, the
- 19 board of regents shall elect a chairperson and up to two vice-
- 20 chairpersons whose terms shall be from July 1 to June 30 of the
- 21 next year or thereafter until their successors are elected. The
- 22 board shall appoint a secretary, who shall not be a member of



- 1 the board. The president of the university shall act as
- 2 executive officer of the board. A majority of the board of
- 3 regents shall constitute a quorum to conduct business, and the
- 4 concurrence of a majority of all the members to which the board
- 5 of regents is entitled shall be necessary to make any action of
- 6 the board of regents valid. The board shall meet at least ten
- 7 times annually and, from time to time, may meet in each of the
- 8 counties of Hawaii, Maui, and Kauai.
- 9 [(c)] (d) The governor shall notify the [regents]
- 10 candidate advisory council for the board of regents of the
- 11 University of Hawaii in writing within ten days of receiving
- 12 notification that a member of the board of regents is resigning,
- 13 has died, or is being removed by the governor.
- 14 [(d)] (e) The members of the board of regents shall serve
- 15 without pay but shall be entitled to their travel expenses
- 16 within the State when attending meetings of the board or when
- 17 actually engaged in business relating to the work of the board."
- 18 SECTION 4. Section 304A-104.5, Hawaii Revised Statutes, is
- 19 repealed.
- 20 ["\frac{\$304A-104.5}{} Regents candidate advisory council for the
- 21 board of regents of the University of Hawaii. (a) There is
- 22 established the regents candidate advisory council for the board

of regents of the University of Hawaii to present to the 1 governor pools of qualified candidates from which the members of 2 the board of regents shall be nominated and, by and with the 3 consent of the senate, appointed by the governor. The regents 4 candidate advisory council shall establish the criteria for 5 qualifying, screening, and presenting to the governor candidates 6 for membership on the board of regents. The regents candidate 7 advisory council shall be attached to the University of Hawaii 8 9 for administrative purposes. 10 (b) Except as provided in subsection (c), the regents candidate advisory council shall present no fewer than two and 11 **12** no more than four qualified candidates for each seat on the board of regents to the governor within: 13 (1) Sixty days of a vacancy that arises by resignation, 14 death, or removal by the governor; or 15 (2) One hundred twenty days prior to the expiration of a 16 17 term. The regents candidate advisory council shall be deemed to have 18 fulfilled its obligation under this section upon presentation of 19 the names of the minimum number of candidates required to be 20 presented for each seat or seats on the board of regents. 21

1	(c)	When there are multiple seats vacant within the same
2	county or	within the at-large membership, the regents candidate
3	advisory	council shall present candidates for seats on the board
4	of regent	s to the governor as follows:
5	(1)	For two seats from the same county or two at large
6		seats, no fewer than four and no more than six
7		candidates;
8	(2)	For three seats from the same county, no fewer than
9		five and no more than eight candidates; and
10	(3)	For more than three seats, the regents candidate
11		advisory council shall determine appropriate minimum
12		numbers of candidates, which shall provide for at
13		least three candidates for the final seat, and maximum
14		numbers of candidates.
15	- (d)	In making its presentations, the regents candidate
16	advisory	council shall:
17	(1)	Develop a statement that includes the selection
18		criteria to be applied and a description of the
19		responsibilities and duties of a member of the board
20		of regents and distribute this statement to potential
21		candidates;

1	(2)	Screen and qualify candidates for each position on the
2		ooard of regents based on their background,
3		experience, and potential for discharging the
4		responsibilities of a member of the board of regents;
5	(3)	Publicly advertise pending vacancies and actively
6		solicit and accept applications from potential
7		candidates;
8	(4)	Develop and implement a fair, independent, and
9		nonpartisan procedure for selecting candidates to
10		serve on the board of regents;
11	(5)	Ensure student involvement by establishing a student
12		advisory group composed of:
13		(A) The senior student affairs officer of the
14		University of Hawaii system;
15		(B) No fewer than three student representatives from
16		the University of Hawaii student caucus who shall
17		represent, to the maximum extent possible, the
18		interests of the various University of Hawaii
19		campuses on each island; and
20		(C) No fewer than three student life advisors who
21		shall represent, to the maximum extent possible,

3	who shall work with and assist the regents candidate	
4	advisory council to recruit and evaluate candidates	
5	for the student member of the board of regents and

9	(6) Require each candidate to disclose any existing or	
10	anticipated contracts with the University of Hawaii o	ЭŦ

13	Upon submission of the names of candidates to the governor, the	.
14	regents candidate advisory council shall make available the	
15	names of candidates to the public through the University of	
16	Hawaii.	
17	(e) For each board seat to be filled, the governor shall	
18	select one nominee from among the candidates submitted by the	
19	regents candidate advisory council.	
20	(f) The regents candidate advisory council shall consist	
21	of seven members to be appointed without regard to section 26	3-4
22	as follows:	

1	(1)	One member shall be appointed by the president of the
2		senate;
3	(2)	One member shall be appointed by the speaker of the
4		house of representatives;
5	(3)	One member shall be appointed by the governor;
6	(4)	One member shall be appointed by one of the co-chairs
7		of the All Campus Council of Faculty-Senate Chairs of
8		the University of Hawaii. A person may not be
9		appointed as a member of the regents candidate
10		advisory council under this paragraph, if within the
11		five years immediately preceding that appointment, the
12		person served on the All Campus Council of Faculty
13		Senate Chairs of the University of Hawaii;
14	(5)	One member shall be appointed by the chairperson of
15		the Executive Council of the University of Hawaii
16		Student Caucus. A person may not be appointed as a
17		member of the regents candidate advisory council under
18		this paragraph, if within one year immediately
19		preceding that appointment, the person served on the
20		Executive Council of the University of Hawaii Student
21		Caucus;

1	(6) One-member shall be appointed by the chairperson of
2	the Association of Emeritus Regents; and
3	(7) One member shall be appointed by the president of the
4	University of Hawaii Alumni Association;
5	provided that members appointed under paragraphs (4) to (7)
6	shall be selected from the general public and may include
7	members of the constituencies represented; provided further that
8	each appointee satisfies the requirements for appointment
9	provided in this subsection.
10	The regents candidate advisory council shall be selected in
11	a wholly nonpartisan manner. Appointees to the regents
12	candidate advisory council shall have a general understanding of
13	the purposes of higher education, the mission of the University
14	of Hawaii system, and the responsibilities of the board of
15	regents. Appointees shall be individuals who are widely viewed
16	as having placed the broad public interest ahead of special
17	interests, having achieved a high level of prominence in their
18	respective professions, and being respected members of the
19	community.
20	(g) Members of the regents candidate advisory council
21	shall serve four year terms.

         (h) If a vacancy occurs, a successor shall be appointed in
    the same manner and subject to the same qualifications as the
2
    person's predecessor. The person appointed to fill a vacancy
3
    shall serve for the remainder of the term of the person's
4

    predecessor.
         (i) The regents candidate advisory council shall operate
6
7
    in a wholly nonpartisan manner. No individual, while a member
    of the regents candidate advisory council, shall run for or hold
8

    any elected office under the United States or the State or any

    of its political subdivisions.

         (i) The members of the regents candidate advisory council
    shall choose a chairperson from among themselves. A majority of
12

    all the members to which the regents candidate advisory council
    is entitled shall constitute a quorum to conduct business. The
14
    concurrence of a majority of all the members to which the
15
    regents candidate advisory council is entitled shall be
16

    necessary to make any action of the regents candidate advisory
18
    council valid. The regents candidate advisory council shall
19
    meet annually and at other times as necessary. The regents
20
    candidate advisory council shall be exempt from part I of
21
    chapter 92.

1	(k) Members of the regents candidate advisory council
2	shall serve without compensation but shall be reimbursed for
3	expenses, including travel, board, and lodging expenses,
4	necessary for the performance of their duties.
5	(1) Notwithstanding chapter 92F or any other law to the
6	contrary, all information required by the regents candidate
7	advisory council shall be confidential, including without
8	limitation, all-council information obtained, reviewed, or
9	considered before and after council decisionmaking.
10	Confidential regents candidate advisory council information
11	shall include documents, data, or other information that are not
12	of public record, including without limitation, personal
13	financial information; the names of applicants; applications and
14	the personal, financial, and other information contained therein
15	submitted by the applicants to the regents candidate advisory
16	council; interviews; schedules; reports; studies; background
17	checks; credit reports; surveys and reports prepared for or on
18	the regents candidate advisory council's behalf; the results of
19	any evaluations or assessments conducted by the regents
20	candidate advisory council; the substance and details of any
21	discussions with regents candidate advisory council members; and
22	the substance and details of discussions and deliberations of

- 1 the regents candidate advisory council and any of its committees
- 2 during meetings."]
- 3 SECTION 5. The members of the candidate advisory council
- 4 for the board of regents of the University of Hawaii who are
- 5 serving on the effective date of this Act shall serve until the
- 6 council is reconstituted by the governor's appointment of seven
- 7 members to the council pursuant to this Act, at which time the
- 8 members of the regents candidate advisory council who are
- 9 serving on the effective date of this Act shall be discharged
- 10 from office and the members appointed directly by the governor
- 11 pursuant to this Act shall begin their service. The governor
- 12 shall appoint seven members to the council no later than
- 13 days after the effective date of this Act.
- 14 SECTION 6. Statutory material to be repealed is bracketed
- 15 and stricken. New statutory material is underscored.
- 16 SECTION 7. This Act shall take effect on July 1, 2050.
