A BILL FOR AN ACT

RELATING TO PUBLIC WORKS OF ART.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to honor the memory
- 2 of the late United States Senator Daniel K. Inouye and the late
- 3 United States Representative Patsy T. Mink and to use their
- 4 examples to inspire current and future generations.
- 5 (a) The comptroller and the state foundation
- on culture and the arts shall commission a permanent, three-6
- 7 dimensional work of art to portray the life, vision,
- 8 accomplishments, impact, and legacy of the late United States
- 9 Senator Daniel K. Inouye so as to properly honor his memory and
- 10 to utilize his example as an inspiration for current and future
- 11 generations.
- 12 The state foundation on culture and the arts, at the
- 13 earliest opportunity, shall issue a call for design entries;
- 14 provided that the design shall include but need not be limited
- to a likeness of Daniel K. Inouye at some stage of his life. 15
- Notwithstanding any other law or rule to the contrary, 16
- 17 the winning design shall be selected, in consultation with the

- 1 SECTION 4. There is appropriated out of the works of art
- 2 special fund the sum of \$225,000 or so much thereof as may be
- 3 necessary for fiscal year 2013-2014 and the same sum or so much
- 4 thereof as may be necessary for fiscal year 2014-2015 for the
- 5 comptroller and state foundation on culture and the arts to
- 6 commission art pursuant to sections 2 and 3 of this Act.
- 7 The sums appropriated shall be expended by the department
- 8 of accounting and general services for the purposes of this Act.
