A BILL FOR AN ACT

RELATING TO FIREARMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 Under Hawaii's existing laws, a person arriving 2 in the State with a firearm is required to register the firearm, 3 but no permit process or background check is required. Therefore, individuals who might have been prohibited from 4 5 acquiring a firearm in Hawaii can acquire a firearm outside of 6 this State, where a permit process or extensive background check 7 may not be required, then possess and be considered registered firearm owners after registering with the county police 8 9 department. 10 The purpose of this Act is to require persons arriving in 11 the State with firearms to undergo a background check before 12 registering a firearm with the county police department.

By amending subsection (a) to read: 6 "(a) Every person arriving in the State who brings or by any other manner causes to be brought into the State a firearm 7 8 of any description, whether usable or unusable, serviceable or 9 unserviceable, modern or antique, shall register the firearm 10 within [three] five days after arrival of the person or of the 11 firearm, whichever arrives later, with the chief of police of 12 the county of the person's place of business or, if there is no place of business, the person's residence or, if there is 13 14 neither a place of business nor residence, the person's place of 15 sojourn. A nonresident alien may bring firearms not otherwise 16 prohibited by law into the State for a continuous period not to 17 exceed ninety days; provided that the person meets the 18 registration requirement of this section and the person 19 possesses: 20 (1) A valid Hawaii hunting license procured under chapter 21 183D, part II, or a commercial or private shooting 22 preserve permit issued pursuant to section 183D-34;

1 (2) A written document indicating the person has been 2 invited to the State to shoot on private land; or 3 (3) Written notification from a firing range or target 4 shooting business indicating that the person will 5 actually engage in target shooting. 6 The nonresident alien shall be limited to a nontransferable 7 registration of not more than ten firearms for the purpose of the above activities. 8 9 Every person registering a firearm under this subsection 10 shall be fingerprinted and photographed by the police department of the county of registration; provided that this requirement 11 12 may be waived where fingerprints and photographs are already on 13 file with the police department. The police department shall 14 perform an inquiry on the person by using the National Instant 15 Criminal Background Check System before any determination to 16 register a firearm is made." 17 2. By amending subsection (e) to read: 18 "(e) No fee shall be charged for the registration[-] of a 19 firearm under this section, except for a fee chargeable by and 20 payable to the registering county for persons registering a 21 firearm under subsection (a), in an amount equal to the fee 22 actually charged by the Federal Bureau of Investigation to the

- 19 SECTION 5. This Act shall take effect on July 1, 2050.

Firearm Registration; Appropriation

Description:

Requires county police departments to fingerprint, photograph, and perform background checks on individuals who wish to register a firearm that was procured out-of-state. Authorizes the police departments to assess a fee for conducting a fingerprint check and specifies the amount of the fee. Extends the time period for registering a firearm procured out-of-state, for consistency with the time period for registering firearms obtained in or imported into the State. Appropriates funds for county implementation. Effective 07/01/2050. (SD2)
