# A BILL FOR AN ACT

RELATING TO MOTOR VEHICLE INSURANCE.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Chapter 431, Hawaii Revised Statutes, is  
2 amended by adding a new section to article 10C to be  
3 appropriately designated and to read as follows:

4           "§431:10C- Mandatory electronic reporting of liability  
5 insurance status. (a) Before July 1, 2014, each insurer that  
6 issues motor vehicle insurance policies shall advise the  
7 commissioner of the electronic method to be used for reporting  
8 liability insurance information under subsections (b), (c), and  
9 (d). The commissioner shall establish an electronic conversion  
10 schedule.

11           (b) Before January 1, 2015, each insurer shall report all  
12 existing motor vehicle liability insurance policies for vehicles  
13 registered in this State to the commissioner in a manner that  
14 preserves existing reporting relationships and that allows for  
15 smaller insurers and those with unusual circumstances to be  
16 accommodated, consistent with the intent of this section.  
17 Accommodation methods that may be made under this subsection  
18 include but are not limited to an extension of the mandatory



1 electronic reporting deadline set forth in this section to no  
2 later than July 1, 2015.

3 (c) After December 31, 2014, each insurer shall  
4 electronically report to the commissioner all issued motor  
5 vehicle liability policies within thirty days of the effective  
6 date of the coverage.

7 (d) After December 31, 2014, each insurer shall  
8 electronically report to the commissioner the cancellation or  
9 nonrenewal of a reported policy or any change of information  
10 previously reported under subsection (b) or (c), as specified by  
11 the commissioner, within forty-five days of the date of  
12 cancellation, nonrenewal, or change. This report shall include  
13 the effective date of the cancellation or amendment, or the last  
14 date of coverage in the case of a nonrenewal, and any other  
15 information that does not exceed information required under  
16 subsection (c).

17 (e) The commissioner, pursuant to chapter 91, may adopt  
18 rules for reporting insurance information, including but not  
19 limited to establishing acceptable timeframes and approved  
20 methods for reporting information."

21 SECTION 2. New statutory material is underscored.

**Report Title:**

Motor Vehicle Insurance; Cancellation; Nonrenewal; Reporting

**Description:**

Requires motor vehicle insurers to report all existing liability insurance policies to the insurance commissioner before 1/1/15 and to report before 7/1/14 the electronic method they will use to report liability insurance to the insurance commissioner. Effective 1/1/15, requires motor vehicle insurers to electronically report to the insurance commissioner all issued policies within 45 days. Requires each insurer to report cancelled, nonrenewed, altered, and new policies.
