# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to program planning,  
4 analysis, and budgeting (BUF 101) the following sums or so much  
5 thereof as may be necessary to fund for fiscal biennium 2013-  
6 2015 all collective bargaining cost items in the agreements  
7 negotiated with the exclusive bargaining representative of  
8 collective bargaining unit (6):

3 SECTION 14. Funds appropriated or authorized by this Act  
4 that are not expended or encumbered by June 30, 2014, and June  
5 30, 2015, of the respective fiscal years, shall lapse as of  
6 those dates.

7 SECTION 15. This Act shall take effect on July 1, 2030.

Collective Bargaining; Cost Items; Salary Increases; Collective Bargaining Unit (6); Appropriations

Appropriates funds for fiscal biennium 2013-2015 for public employees in collective bargaining unit (6) and for employees excluded from collective bargaining that are on the same compensation plans as those officers and employees within collective bargaining unit (6). Effective July 1, 2030.
