# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to program planning,  
4 analysis, and budgeting (BUF 101) the following sums or so much  
5 thereof as may be necessary to fund for fiscal biennium 2011-  
6 2013 all collective bargaining cost items contained in the  
7 agreements negotiated with the exclusive bargaining  
8 representative of collective bargaining unit (9):

14 SECTION 12. Funds appropriated by this part shall be  
15 allotted by the director of finance to the Hawaii health systems

18 PART VII

19 SECTION 13. Salary increases and cost adjustments provided  
20 in this Act for any officer or employee whose compensation is  
21 paid, in whole or in part, from federal, special, or other funds

1 shall be paid wholly or proportionately, as the case may be,  
2 from the respective funds.

3 SECTION 14. This Act shall take effect on July 1, 2030;  
4 provided that the funds appropriated or authorized by this Act  
5 shall apply retroactively to July 1, 2011.



**Report Title:**

Collective Bargaining; Cost Items; Salary Increases; Collective Bargaining Unit (9); Appropriations

**Description:**

Appropriates funds for fiscal biennium 2011-2013 for public employees in collective bargaining unit (9) and for employees excluded from collective bargaining that are on the same compensation plans as those officers and employees within collective bargaining unit (9). Applies retroactively to July 1, 2011. Effective July 1, 2030. (SB908 HD1)
