Your Committee on Transportation, to which was referred H.B. No. 1440 entitled:

"A BILL FOR AN ACT RELATING TO DRIVER EDUCATION,"

begs leave to report as follows:

The purpose of this measure is to increase awareness about organ and tissue donation among new drivers by requiring driver education programs to include the distribution of information on organ and tissue donation and the possibility of saving lives through organ and tissue donation under Hawaii's law on the designation of an anatomical gift.

A council member of the City and County of Honolulu, Legacy of Life Hawaii, and a concerned individual supported this measure. The Department of Education opposed this measure.


Your Committee has amended this measure by changing its effective date to July 1, 2020, to promote further discussion.
