Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 816, S.D. 1, entitled:

"A BILL FOR AN ACT MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to provide a legislative vehicle to fund pending public sector collective bargaining cost items for salary adjustment and other cost adjustments for public employees in collective bargaining unit (1) and their excluded counterparts for fiscal biennium 2013-2015.

Your Committee on Conference has amended this measure by:

- (1) Inserting additional funding sources and specified sums for collective bargaining cost items for unit (1) and its excluded counterparts, including the cost of salary



adjustments negotiated between the State and the bargaining unit representative for collective bargaining unit (1) for fiscal biennium 2013-2015;


- (2) Changing its effective date to July 1, 2013; and
- (3) Making technical, nonsubstantive amendments for clarity, consistency, and style.

No. 816, S.D. 1, as amended herein, and recommends that it pass Final Reading in the form attached hereto as H.B. No. 816, S.D. 1, C.D. 1.




