Your Committee on Energy & Environmental Protection, to which was referred H.C.R. No. 128 entitled:

"HOUSE CONCURRENT RESOLUTION URGING THE DEPARTMENT OF LAND AND NATURAL RESOURCES AND THE NATIONAL OCEANIC AND ATMOSPHERIC ADMINISTRATION TO MAKE AVAILABLE TO THE PUBLIC AN ANNUAL REPORT ON THE STATE'S ENDANGERED MARINE ANIMALS,"

begs leave to report as follows:

The purpose of this measure is to request:

- (1) The United States National Oceanic and Atmospheric Administration to provide an annual report of the State's endangered marine life to the Department of Land and Natural Resources; and
- (2) The Department of Land and Natural Resources to make the report available to the public by posting the report to its website.

A few individuals provided testimony in support of this measure. The Department of Land and Natural Resources and an individual provided comments on this measure.

Your Committee has amended this measure by:

- (1) Inserting a provision that requests the National Oceanic and Atmospheric Administration to make an annual report

on the State's endangered marine life available to the public by posting the report to its website; and

- (2) Making technical, nonsubstantive amendments for the purpose of clarity and consistency.

No. 128, as amended herein, and recommends that it be referred to the Committees on Ocean, Marine Resources, & Hawaiian Affairs and Water & Land in the form attached hereto as H.C.R.
