& Hawaiian Affairs, to which was referred H.C.R. No. 144 entitled:

"HOUSE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A
TERM, NONEXCLUSIVE EASEMENT COVERING A PORTION OF STATE
SUBMERGED LANDS LOCATED IN HEEIA, KOOLAUPOKO, OAHU, FOR THE
USE, MAINTENANCE, REPAIR, AND REMOVAL OF AN EXISTING PIER,"

The purpose of this measure is to authorize the Board of Land
and Natural Resources to issue a nonexclusive easement for a 55-
year term covering a portion of state submerged lands located in
Heeia, Koolaupoko, Oahu, for purposes of use, maintenance, repair,
and removal of an existing pier.

The Department of Land and Natural Resources supported this
measure.

it be referred to the Committee on Finance.


