Your Committee on Health, to which was referred H.C.R. No. 199 entitled:

"HOUSE RESOLUTION URGING THE DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS AND THE AMERICAN ASSOCIATION FOR MARRIAGE AND FAMILY THERAPY: HAWAII DIVISION, TO DEVELOP DRAFT LEGISLATION ESTABLISHING, IMPLEMENTING, AND MONITORING CONTINUING EDUCATION REQUIREMENTS FOR ALL LICENSED MARRIAGE AND FAMILY THERAPISTS IN HAWAII,"

The purpose of this measure is to ensure the quality of services provided by licensed marriage and family therapists by requesting the Department of Commerce and Consumer Affairs and the American Association for Marriage and Family Therapy: Hawaii Division to develop draft legislation establishing continuing education requirements for licenses.
