begs leave to report as follows:

The purpose of this measure is to enable the resumption of
discussions aimed at resolving outstanding issues related to
housing for individuals transitioning from institutionalization or
residential treatment settings to independent living by
reconvening the Clean and Sober Homes and Halfway Houses Task
Force that was convened by the Director of Health in response to
changes to the criminal justice system due to Acts 139 and 140,
Session Laws of Hawaii 2012.

The Hawaii Substance Abuse Coalition supported this measure
with amendments.

Upon consideration, your Committee has amended this measure
by:

- (1) Changing the term "community home" to "community support
home" to reflect generally-used language; and
- (2) Making a technical, nonsubstantive amendment for
clarity.
