The purpose of this measure is to expand the exceptions on  
the use of a government motor vehicle for personal use to include  
an officer or employee of any county board of water supply, rather  
than only the Board of Water Supply of the City and County of  
Honolulu.

The Kauai Board of Water Supply supported this measure.

Your Committees have amended this measure by:

- (1) Changing its effective date to July 1, 2050, to promote  
further discussion; and
- (2) Making technical, nonsubstantive amendments for clarity,  
consistency, and style.

As affirmed by the records of votes of the members of your  
Committees on Transportation and Labor & Public Employment that  
are attached to this report, your Committees are in accord with  
the intent and purpose of S.B. No. 1230, as amended herein, and  
recommend that it pass Second Reading in the form attached hereto




