Madam:

Your Committee on Public Safety, Intergovernmental and
Military Affairs, to which was referred S.B. No. 1230 entitled:

"A BILL FOR AN ACT RELATING TO GOVERNMENT MOTOR VEHICLES,"

begs leave to report as follows:

The purpose and intent of this measure is to expand the
exceptions on the use of a government motor vehicle for personal
use to include an officer or employee of any county board of water
supply, rather than only the Board of Water Supply of the City and
County of Honolulu.

Your Committee received testimony in support of this measure
from the Department of Water, County of Kauai.

Your Committee finds that county employees on neighbor
islands should not be treated differently than county employees in
Honolulu when operating government motor vehicles under personal
use exceptions. This measure provides the employees of the
various boards of water supply with a more equitable government
motor vehicle policy.

As affirmed by the record of votes of the members of your
Committee on Public Safety, Intergovernmental and Military Affairs
that is attached to this report, your Committee is in accord with
the intent and purpose of S.B. No. 1230 and recommends that it
pass Second Reading and be placed on the calendar for Third
Reading.
