Your Committee on Finance, to which was referred S.B. No. 5,
S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO PUBLIC LANDS,"

The purpose of this measure is to provide fair compensation,
in addition to rent reductions, to lessees when the State
withdraws, condemns, or takes public land leased for intensive
agricultural or pastoral uses and renders the land unusable for
the original purposes of the lease.

Hawaii Farm Bureau Federation; KK Ranch; Hawaii Cattlemen's
Council, Inc.; Ulupono Initiative; 4 Ag Hawaii; Mikilua Poultry
Farm, Inc.; Kealia Ranch; Hawaii Aquaculture and Aquaponics
Association; Wong's Meat Market Ltd; Maui Cattlemen's Association;
and several concerned individuals submitted testimony in support
of this measure. The Department of Land and Natural Resources and
Department of Agriculture offered comments.

Your Committee has amended this measure by:


- (1) Changing its effective date to July 1, 2030, to
