- (1) Making a general fund appropriation of an unspecified
amount for fiscal year 2013-2014 and for fiscal year
2014-2015 into the 'Ulu'ulu: The Henry Ku'ualoha Giugni
Moving Image Archive of Hawai'i Special Fund (Special
Fund); and
- (2) Authorizing the appropriation of an unspecified amount
for fiscal year 2013-2014 and for fiscal year 2014-2015
out of the Special Fund to support the activities of the
Archive.

The Department of Business, Economic Development, and
Tourism, University of Hawaii-West Oahu, and several concerned
individuals testified in support of this measure.
