Your Committee has amended this measure by:

- Defining the term "contemptuous conduct" to enhance the clarity of the measure;
- (2) Changing its effective date to July 1, 2030, to encourage further discussion; and
- (3) Making technical, nonsubstantive amendments for clarity, consistency, and style.


