Your Committee on Ways and Means, to which was referred  
S.C.R. No. 27 entitled:

"SENATE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENT OF  
EDUCATION TO MEET WITH INTERESTED PARTIES TO EXAMINE THE  
FEASIBILITY OF ESTABLISHING A BOXING PILOT PROGRAM IN AT  
LEAST ONE OF HAWAII'S PUBLIC HIGH SCHOOLS,"

The purpose and intent of this measure is to request the  
Department of Education to meet with interested parties to examine  
the feasibility of establishing a boxing pilot program in at least  
one of Hawaii's public high schools.

Your Committee received written comments in support of this  
measure from the Department of Education.

Your Committee finds that while boxing provides valuable  
skills that can be used throughout life, such as self-defense and  
sportsmanship, young adults in Hawaii can currently participate in  
boxing only through the use of private boxing gyms and facilities,  
which can be costly.

As affirmed by the record of votes of the members of your  
Committee on Ways and Means that is attached to this report, your  
Committee concurs with the intent and purpose of S.C.R. No. 27 and  
recommends its adoption.
