Creates a new chapter to authorize the governor to appoint commissioners to administer oaths, take acknowledgements, and proofs of execution outside of the United States in connection with the execution of conveyance documents relating to a timeshare interest, any property subject to a time share plan, or the operation of a time share plan covering any property located within the State. <b><u>SB 1209, SD1</u></b> <a href="#">(SSCR112)</a> <a href="#">Status &amp; Testimony</a>	RELATING TO HIGHWAYS. Authorizes the director of transportation, upon application, to issue a written permit authorizing the applicant to vend in the airspace above a highway. (SD1)	TIA, CPN
