necessary for fiscal year 2012-2013, out of the Nursing Facility
Sustainability Program Special Fund with such moneys to be used
consistent with the Nursing Facility Sustainability Program Special
Fund, including the reimbursement of moneys advanced for those
purposes in fiscal year 2012-2013 from the health care payments
program (HMS 401).

RELATING TO HEALTH.

Requires the department of health and the department of human services to post on their respective websites reports of all inspections in which a violation was discovered at certain care facilities by January 1, 2015.

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.

Testimony submitted will be placed on the legislative website after the hearing adjourns. This public posting of testimony on the website should be considered when including personal information in your testimony.
