| <p><u>SB 1386</u> <u>Status & Testimony</u></p> | <p>RELATING TO THE BOARD OF REGENTS OF THE UNIVERSITY OF HAWAII. Requires members of the board of regents of the University of Hawaii to file an annual disclosure of financial interests with the state ethics commission. Makes the disclosures public record and available for inspection and duplication.</p> | <p>HRE, JDL</p> |



Amends section 304A-104.5, HRS, to give the governor the authority to reject the list of nominees to the board of regents of the University of Hawaii presented by the regents candidate advisory council and require the regents candidate advisory council to provide another list of nominees within sixty days.
