SB 381 Status & Testimony	RELATING TO COMPREHENSIVE PUBLIC FUNDING FOR ELECTIONS. Changes funding formula for the comprehensive public funding pilot project to average the amount of money used by winning candidates in the last two election cycles for all county district races. Limits the number of candidates in the pilot program to twenty-five per election cycle.	JDL, WAM
SB 854 Status & Testimony	RELATING TO ELECTIONS. Requires the Office of Elections to implement a program allowing voters to register to vote on election day and to vote by mail for all elections beginning in 2016.	JDL, WAM
SB 853 Status & Testimony	RELATING TO THE ELECTIONS COMMISSION. Specifies the duty of the elections commission to provide oversight of the chief elections officer.	JDL
SB 834 Status & Testimony	RELATING TO ELECTION OBSERVERS. Specifies the purposes of the elections observer program and the duty of the chief election officer to implement and maintain the program.	JDL
SB 966 Status & Testimony	RELATING TO THE UNIFORM MEDIATION ACT. Adopts the Uniform Mediation Act of the National Conference of Commissioners on Uniform State Laws.	JDL
SB 465 Status & Testimony	RELATING TO TORT ACTIONS. Creates a civil cause of action of constructive invasion of privacy if the person obtains any type of visual image, sound recording, or other physical impression of another person under circumstances in which another person has a reasonable expectation of keeping private their personal life under certain conditions.	JDL
