(SSCR550)
Status

RELATING TO CONTRACTORS.
Requires any person applying for a license as an electrical contractor, pole and line contractor, high voltage electrical contractor, or electronic systems contractor to possess a trade license to perform electrical work in the State. Provides an exemption for employees of a public utility within the State. (SD1)
