<u>SB 3</u> <u>Status & Testimony</u>	RELATING TO THE OFFICE OF HAWAIIAN AFFAIRS. Provides for the election of the office of Hawaiian affairs board members through a system of nonpartisan primary and general elections to begin with the 2014 elections.	THA, JDL
<u>SB 403</u> <u>Status & Testimony</u>	RELATING TO BONDS. Authorizes the office of Hawaiian affairs to issue revenue bonds to fund a loan program.	THA, WAM
<u>SB 407</u> <u>Status & Testimony</u>	RELATING TO ISLAND BURIAL COUNCILS. Clarifies statutory provisions relating to composition and quorum of island burial councils.	THA
<u>SB 408</u> <u>Status & Testimony</u>	RELATING TO THE BUDGET OF THE OFFICE OF HAWAIIAN AFFAIRS. Appropriates funds for the office of Hawaiian affairs for the fiscal biennium beginning 07/01/2013 and ending 06/30/2015. Effective 07/01/2013.	THA, WAM
<u>SB 320</u> <u>Status & Testimony</u>	RELATING TO NATIVE HAWAIIAN BURIALS. Requires that iwi kupuna, or Native Hawaiian bones, in the possession of the State whose provenience is unknown, or for other special circumstance, be reinterred annually on the island of Kaho'olawe.	THA, WAM
