
<u>HB 1255</u> <u>Status</u>	RELATING TO LAND USE. Establishes the Honokohau Marina Community Development District on the island of Hawaii under the Hawaii Community Development Authority.	WAL/OMH
<u>HB 1327</u> <u>Status</u>	RELATING TO STATE AGENCIES. Increases the membership of the BLNR, commission on water resource management, and LUC, respectively, to include a member to represent the interests of the OHA.	WAL/OMH
<u>HB 1064</u> <u>Status</u>	RELATING TO CEDED LANDS. Requires the Department of Land and Natural Resources to conduct an audit of all state-held lands and an inventory of ceded lands, and report to the Legislature prior to the convening of the 2014 session.	WAL/OMH, FIN
