Wednesday, March 13, 2013

The House of Representatives of the Twenty-Seventh Legislature of the State of Hawaii, Regular Session of 2013, convened at 12:08 o'clock p.m., with Speaker Souki presiding.

The invocation was delivered by Representative Angus L.K. McKelvey, after which the Roll was called showing all Members present with the exception of Representatives Mizuno and Ward, who were excused.

Representative Belatti, for the Committee on Health, presented a report (Stand. Com. Rep. No. 932), recommending that H.C.R. No. 21, as amended in HD 1, be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Awana and carried, the report of the Committee was adopted and H.C.R. No. 21, HD 1, entitled: "HOUSE CONCURRENT RESOLUTION REQUESTING THE STATE OF HAWAII TO SUPPORT THE EFFORTS OF THE HAWAII HEALTH CARE PROJECT AND THE HAWAII HEALTH INFORMATION EXCHANGE TO IMPLEMENT AN EFFICIENT AND EFFECTIVE, INTEGRATED, TECHNOLOGY-BASED HEALTHCARE INFORMATION SYSTEM," was referred to the Committee on Finance, with Representative Mizuno being excused.

Representative Belatti, for the Committee on Health, presented a report (Stand. Com. Rep. No. 933), recommending that H.C.R. No. 20, as amended in HD 1, be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Awana and carried, the report of the Committee was adopted and H.C.R. No. 20, HD 1, entitled: "HOUSE CONCURRENT RESOLUTION ESTABLISHING A WORKING GROUP TO DEVELOP NUTRITION GUIDELINES FOR STATE AGENCIES," was referred to the Committee on Finance, with Representative Mizuno being excused.

Representative Belatti, for the Committee on Health, presented a report (Stand. Com. Rep. No. 934), recommending that H.C.R. No. 24, as amended in HD 1, be referred to the Committee on Finance.

On motion by Representative Saiki, seconded by Representative Awana and carried, the report of the Committee was adopted and H.C.R. No. 24, HD 1, entitled: "HOUSE CONCURRENT RESOLUTION REQUESTING THE UNIVERSITY OF HAWAII DEPARTMENT OF KINESIOLOGY AND REHABILITATION SCIENCE, IN COOPERATION WITH THE DEPARTMENT OF EDUCATION AND THE DEPARTMENT OF HEALTH, TO CONDUCT A STUDY AND PROVIDE RECOMMENDATIONS ON THE IMPLEMENTATION OF NATIONAL PHYSICAL EDUCATION GUIDELINES IN HAWAII'S PUBLIC SCHOOLS," was referred to the Committee on Finance, with Representative Mizuno being excused.

Representative Takumi, for the Committee on Education, presented a report (Stand. Com. Rep. No. 935) recommending that S.B. No. 48 pass Second Reading and be referred to the Committee on Ocean, Marine Resources, & Hawaiian Affairs.

On motion by Representative Saiki, seconded by Representative Awana and carried, the report of the Committee was adopted and S.B. No. 48, entitled: "A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF EDUCATION," passed Second Reading and was referred to the Committee on Ocean, Marine Resources, & Hawaiian Affairs, with Representative Mizuno being excused.

THIRD READING

H.B. No. 200, HD 1:

Representative Luke moved that H.B. No. 200, HD 1 pass Third Reading, seconded by Representative Nishimoto.

Representative Luke rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I rise to speak in favor of House Bill 200, the budget bill for the Executive Branch. Thank you. Mr. Speaker, first and foremost I want to thank my Vice Chairs for their support and assistance and the committee members for standing alongside me to craft this budget. To the veterans on the committee, thank you for your insight and experience. And to the freshmen on the committee, I want to thank them for their enthusiasm and their willingness to learn.

"I would also like to thank the CIP sub-chair for evaluating the numerous requests. In his fiscal prudence, we are proposing a GO bond appropriation lower than what was proposed by the Administration. So, thank you very much. I would also like to thank the GIA sub-chair for taking the role of evaluating 224 applications. Having him take on this challenge was terrific because it allowed me and others to give this budget the full attention it deserved, so, thank you very much.

"However, I can't stress enough that this budget would not be possible today without the hard work of the Finance staff. So, Mr. Speaker, please allow me to introduce them at this time. When I call your name, please stand, but Members if you could hold your applause until after I introduce everyone. We have analysts: Dongming Huang, Kara Takasaki, Sachi Takita and Matthew Tsujimura. We have CIP Specialist, Leslie Goo; Budget Supervisor, Puna Chai; Budget Chief, Susan Fernandez; and Committee Clerk, Nan Kalupahana, who is hiding behind me in the media box somewhere.

"A lot of times these folks work so late in the hours and they are the ones who put this budget together to make us look good and a lot of times these people work directly with the Committee Chairs and the Members. I can't really show my appreciation enough and there's not enough lunches I can buy for them that's going to repay all the hard work that they have done. So, thank you very much. If the Members could just thank them with an applause at this point.

"Mr. Speaker, I'm not ashamed to admit that a lot of times they probably wanted to kill me, so I wanted to thank them for not killing me. So, thank you very much. But our hard work has just started and we will continue to work hard on this budget as it goes through the process.

"At this point I would also like to thank the subject matter Committee Chairs. I was very impressed with the depth of knowledge that each brought and I was especially impressed with the Higher Ed Chair who put all his suggestions in a type-written single-spaced thesis and he submitted in a pronged manila folder to me with tab exhibits. So, next go around, if subject matter Chairs want me to take your suggestions more seriously, then you have to get to the level the Higher Ed Chair has done with his budget suggestions.

"But these are the things that the subject matter Chairs have done. For instance, the Public Safety Chair alerted us about some things that they did in the past and asked us to be prudent in our spending. So, we really appreciate all the subject matter Chairs taking time to look at the budget and giving us guidance. So, thank you very much.

"Mr. Speaker, I would also like to thank you for the confidence and trust you had in me and the committee members in allowing us to craft this budget.

"The Administration, as you know, submitted a budget of over \$6.1 billion in General Funds and over \$11.7 billion in all means of financing for Fiscal Year ending 2014, and over \$6.2 billion in General Funds and over \$12 billion in all means of financing for Fiscal Year ending 2015."

Representative Say rose to yield his time, and the Chair, "so ordered."

Representative Luke continued, stating:

"Thank you very much. Although the Council on Revenues, as you know, will be meeting in about 30 minutes, because we are obligated to use the January 7, 2013 Council of Revenues forecast as our guide, I wanted to just alert the Members that the Council on Revenues, the January 7, 2013 forecast showed a General Fund Revenue of \$6.1 billion in Fiscal Year 14 and \$6.4 billion in Fiscal Year 15.

"Because of this and because of the looming sequestration issues, because of the uncertain collective bargaining costs and because of the numerous appropriation and tax credit bills still going through the legislative process, your committee has taken a conservative approach to tackle and craft this budget. We funded those programs that required immediate attention and balanced competing interests to fulfill the needs of the state.

"In the end, the committee has appropriated about \$5.9 billion in General Funds for Fiscal Year 2014, and about \$6 billion in General Funds for Fiscal Year 2015. Therefore, Mr. Speaker, this is a responsible budget and I proudly present this for your consideration today. Thank you."

At this time, the Chair stated:

"For the Members' indulgence, I will be calling some other Members from the Finance Committee before I get to the general membership."

Representative Onishi rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. First, I'd like to thank you and the leadership of the House for appointing me to the very important Finance Committee. Serving on the Finance Committee has given me the opportunity to get both the overall and detailed perspectives of the financial picture of our state. I would also like to thank Chair Luke, Vice Chairs Nishimoto and Johanson, and all of the Members of the Finance Committee for sharing their insights, knowledge and *mana'o*, for answering the many questions that I had and for their encouragement to actively participate in the committee hearings.

"I would like to highlight our committee's efforts to continue our support of agriculture, which is a very important part of my district as well as the rest of the state. The budget includes important legislation to provide funding for the development and support of irrigation projects, subsidies for livestock feed, livestock feed development and family farms, and expands the agricultural loan program to include infrastructure, infrastructure improvements, implementation of new farming techniques and bio-security projects.

"We supported the education of our youth by including funding to the DOE and UH for the implementation and operation of the Future Farmers of America and 4H programs, and authorized schools to grow food in school gardens for use in their school lunch programs. We continue to support the department's efforts to protect our state from invasive species through providing 19 additional specialists and inspectors, and 4 inspectors and funds for the detector dog program.

"Finally, I too would like to thank the Finance Committee staff for their hard work, dedication, and for putting in the many long hours necessary to support us and our efforts to present this budget. I would like to thank all of the departments and agencies for their participation in the process of developing the budget. Thank you, Mr. Speaker."

Representative Lowen rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I also want to thank the Chair and the Vice Chairs, Members of the Finance Committee and the Finance Committee staff for all of their hard work on the budget. There are many important programs, projects and positions that are supported in this budget and I want to highlight a few that, as the Vice Chair of the Water & Land Committee, I've been following this session.

"I'm very happy that this budget includes important funding for watershed protection and natural area reserves management. Fresh water is a limited resource and its availability depends on the health of our forest and watersheds. By providing these funds, the House Finance Committee has taken steps to ensure our future supply of drinking water, which we need to safeguard our prosperity and quality of life.

"The Natural Area Reserves program protects Hawaii's natural resources, many of which can be found nowhere else in the world. The NARS System includes over 100,000 acres of Hawaii's most unique ecosystems, ranging from lava flows, to coastal areas, to tropical rainforest, and provides needed habitat for rare and endangered plants and animals. The reserves also protects the major watershed areas. This budget includes \$8.5 million for Fiscal Years 14 and 15 for watershed management and Natural Area Reserves programs.

"Also in this budget is funding for the Na Ala Hele trail system. These funds will help to preserve trails and increase access to them, including many historic trails, and will promote cultural awareness, environmental stewardship and encourage outdoor recreation.

"Again, these are just a few of the many worthwhile programs that we have been able to support in this budget. Sitting on the Finance Committee has been an exciting and very educational experience and I look forward to our continued work in the future."

Representative Ing rose to speak in support of the measure, stating:

"I rise in support. I too would like to thank the Finance Committee Chair, Vice Chairs, staff and Members for their hard work and patience in going line by line throughout the budget and teaching all of us freshmen. Also to the Members of the Finance Committee and their staff for all the great food.

"I'd like to highlight a few points that I think demonstrate the House's continued commitment to the public safety of our state as the Vice Chair of the Committee on Public Safety. There were nine positions added to provide security and intake services associated with inmates returning from out of state facilities for the Justice Reinvestment Initiative. Mr. Speaker, there was also \$3 million in each Fiscal Year for the rising utility costs included.

"I'd also like to highlight some work done for the Department of Taxation, which includes 12 positions in Fiscal Year 14 in the areas of tax collection to make our system more effective and also \$32 million in GO bonds for a modernization plan to bring it up to date. So, once again, thank you, Finance Committee Chair, Vice Chairs and staff."

Representative Morikawa rose in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support. As a Member of the Finance Committee and Vice Chair for the Health Committee I would like to share some important highlights that will affect the health and safety of our people. We all recognize the significant influence of environmental health programs, food safety issues and the importance of family health for community health and the overall health status of the state.

"To address environmental health services, 16 positions and funds were added for eight vector control workers for increased surveillance of state ports of entry on Oahu, Maui, Hilo and Kona. Eight sanitary workers and related office supplies and computers to address the high number of food safety violations on Oahu and to continue the electronic food inspection and permitting database. Seven environmental and health specialists were

added to administer water quality, green house gas and clear air regulations.

"For state laboratory services in Fiscal Year 14, about \$271,000 and Fiscal Year 15, \$244,000 of General Funds were added for five islands for the microbiology shellfish testing program to support FDA certification of the local shellfish industry and thereby support the export of local shellfish products. Three other items will help identify bacterial causes of outbreaks quicker and at lower cost to the state, and to detect and provide legally defensible confirmation of all classes of compounds for the environmental health analytical services branch.

"For family health services, we added a position in maternal and child health branch to reestablish a violence prevention coordinator position in children and youth services section, who will be responsible for statewide domestic violence planning and programming. In addition, we added \$800,000 in General Funds for both Fiscal Years for Hale Makamae at Kula Hospital, \$91 million in GO bonds for repair and maintenance for HHSC, and \$10 million GO bonds for Waimanu home renovations.

"I would also like to thank the Finance Chair and Vice Chairs and especially the staff for their guidance and leadership in working out the details of this budget. Thank you, Mr. Speaker."

Representative Takayama rose in support of the measure, stating:

"Mr. Speaker, in support. I'd like to highlight a few impacts of HB 200 on the University of Hawaii. To help address the University's huge backlog in R&M, HB 200 includes \$100 million for repairs and maintenance with \$25 million designated for our community college system.

"Recognizing the importance of access to higher education, especially for our neighbor island and rural community students, \$2 million was appropriated for our community colleges, which are an important gateway to four-year degrees and which have seen significant growth and enrollment in recent years.

"The budget also contains \$1 million in each Fiscal Year for operating costs for our new West Oahu Campus to serve the students of Leeward and Central Oahu.

"Finally, to sustain our medical school's Native Hawaiian Center of Excellence, which has lost its federal funding recently, it appropriates \$850,000 each year for this outstanding program. Thank you, Mr. Speaker."

Representative Ohno rose in support of the measure, stating:

"In support. I also want to thank the Chair, Vice Chairs, committee members and staff of the Finance Committee. I'm here to highlight the education portion of the budget. It includes \$12.9 million in additional funds to the weighted student formula. This money is directly used in classrooms for teachers, technology and supplies.

"The budget also includes \$113 million for school improvements and renovations. \$42 million for health and safety and electrical upgrades for our public schools.

"Finally, I'm proud to say the House's budget includes \$800,000 and \$300,000 in the next two years respectively to fund our public libraries. This includes funding for physical books and e-books. Thank you, Mr. Speaker."

Representative Woodson rose in support of the measure, stating:

"Thank you, Mr. Speaker. In support. I'd like to thank the Chair and the Vice Chairs and all the committee members for all their hard work this session on the budget. Mr. Speaker, I'd like to share my perspective on the budget.

"Driving around my community, Mr. Speaker, during the daytime, it appears that everything is normal. If you drive around at night you'll begin to notice something, a recurring theme at each house. At the front of each

house, Mr. Speaker, you'll see 5 cars, 10 cars, sometimes 15 cars, in front of one house. That tells you that people are living together, Mr. Speaker, because of the necessity of financial situations. I bring this up to illustrate the point of the realness of the issues for the need of affordable housing. So I greatly appreciate, Mr. Speaker, the significant investment incorporated into the budget for various rental housing services.

"Besides housing, Mr. Speaker, I also acknowledge that the community members are struggling with the cost of health care. I greatly appreciate \$290 million that was also incorporated into the budget for healthcare and human services resources. A portion of these funds, Mr. Speaker, is going towards enactment of the Affordable Healthcare Act specifically related to the expansion of healthcare coverage and people earning up to 133% of the federal poverty level.

"Another portion, Mr. Speaker, is going to be utilized in terms of payments for primary care providers, health home services and specialized services for our mentally ill, just to name a few. These are all crucial components of enhancing aspects of our human service resources.

"Lastly, it is extremely important, Mr. Speaker, that we take care of our most disadvantaged *keiki*. There is \$6.5 million slated for important programs such as increasing voluntary foster care for kids up to the age of 21 as opposed to the age of 18, and added neighborhood drop-in centers for various locations. These inclusions, Mr. Speaker, are extremely important and are great investments for all of our communities and I am grateful for the opportunity. I stand again in strong support. Thank you."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I rise with slight reservations. Mr. Speaker, I have three doubts about the budget. Number one, it increases spending at a time when we are the edge of a cliff, fiscal cliff, Inouye cliff. Unions have not been funded, and as the good Chair of the Finance Committee said, in a matter of hours the Council on Revenues will give their prognostication of the amount of money we have. Because of those things, I think adding \$300 million to the last biennium may be a little precarious. But this is only now, we are only at Third Reading in the House. It has to go to the Senate, it has to go to Conference Committee, we'll see what's going to happen.

"My second doubt, Mr. Speaker, is that this bill closes the Taiwan Tourism Office. When Chinese visitors are blossoming, when the visa waiver that so many of us in this Body and in Washington worked hard to get is allowing a free flow of Chinese visitors, what do we do? We close the Taiwan office. The Chinese visitor is \$407 per day, our best customer. Mr. Speaker, this is an oversight. It puts a big doubt in my mind as to the efficacy of this.

"Thirdly, Mr. Speaker, this budget puts no check on the rising cost of living for Hawaii's families and is too dependent on fee increases and some hefty, potentially hefty tax hikes and fees that are buried in other parts of this Body and may come out as future parts of legislation. My point is, it's too soon to give it a clean bill of health. It's too soon to brag about it. It looks good so far but until we are at a strong finish point at May 2nd, Mr. Speaker, I have these reservations. Thank you."

Representative Nishimoto rose in support of the measure and asked that his written remarks be inserted into the Journal, and the Chair "so ordered."

Representative Nishimoto's written remarks are as follows:

"Mr. Speaker, I rise in strong support of this measure.

"Mr. Speaker, this budget is a document that showcases the collective and collaborative efforts of many individuals. As you know, the budget process is not an easy one and I'd like to take a moment to acknowledge individuals who played a crucial role in getting us to this point.

"First, I'd like to commend Chair Luke for her leadership, vision and openness to input during the budget process. I'd like to thank all the Members of this Body, and Members of the Finance Committee in

particular, for their efforts in reviewing, evaluating and analyzing the enormous amounts of testimony, data and information.

"And finally, thank you to the Finance staff for their countless hours of behind the scenes work to make this budget possible. They truly are the unsung heroes of the budget process.

"Mr. Speaker, the Finance Committee was pleased that the revenue collections for the state have finally reached and exceeded the amount collected prior to the Great Recession in 2007. As we worked to prepare this budget, however, we remained cautiously optimistic about this encouraging economic trend. With an uncertain fiscal future, resulting from the Inouye cliff and the federal budget sequestration, this budget reflects a conservative approach.

"The Finance Committee envisioned a more stream-lined and efficient government by eliminating positions in departments that have been vacant for over a year. This will increase transparency and accountability in the budget."

Representative Fale rose in support of the measure with reservations and asked that his written remarks be inserted into the Journal, and the Chair "so ordered."

Representative Fale's written remarks are as follows:

"Mr. Speaker, I rise with reservations on House Bill 200, HD 1. This is the House budget bill for the State of Hawaii. Overall, this bill is fiscally responsible. I do like the fact that this bill removes some spending that I feel is frivolous, such as a fashion show. It also reduces the budget amount requested by the Governor by \$600 million.

"Mr. Speaker, unfortunately this bill did not fund an audit of the Department of Education, a department that is allocated a budget of \$3.7 billion dollars. In an economy where costs continue to increase and students at the University of Hawaii are affected negatively by increasing tuition expenses, I feel it is important to know how public money is being spent.

"For these reasons, Mr. Speaker, I rise with reservations on House Bill 200, HD 1."

The motion was put to vote by the Chair and carried, and H.B. No. 200, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE STATE BUDGET," passed Third Reading by a vote of 50 ayes, with Representative Mizuno being excused.
