Friday, April 5, 2013

The House of Representatives of the Twenty-Seventh Legislature of the State of Hawaii, Regular Session of 2013, convened at 12:07 o'clock p.m., with Speaker Souki presiding.

**ORDER OF THE DAY****SUSPENSION OF RULES**

On motion by Representative Awana, seconded by Representative Fukumoto and carried, the rules were suspended for the purpose of considering certain Senate Bills for Third Reading by consent calendar. (Representatives Aquino, Rhoads, Say and Tokioka were excused.)

**UNFINISHED BUSINESS**

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1417) recommending that S.B. No. 930, SD 1, HD 1 pass Third Reading.

Representative Saiki moved that the report of the Committee be adopted, and that S.B. No. 930, SD 1, HD 1 pass Third Reading, seconded by Representative Awana.

At this time, Representative McKelvey offered Floor Amendment No. 12, amending S.B. No. 930, SD 1, HD 1, as follows:

"SECTION 1. Senate Bill No. 930 S.D. 1, H.D.1, RELATING TO THE PACIFIC INTERNATIONAL SPACE CENTER FOR EXPLORATION SYSTEMS SUSTAINABLE CONCRETE INITIATIVE, is amended as follows:

1. By amending section 1 to read:

"SECTION 1. The legislature finds that the Pacific international space center for exploration systems, including its proposed aerospace technology research and development park project, is an economic driver for the island of Hawaii that promotes the establishment and growth of new sustainable and green industries along with associated jobs, workforce development, internships, and science, technology, engineering, and math education programs.

The legislature also finds that the Pacific international space center for exploration systems aerospace technology research and development park project will attract investment that will help leverage the costs of expanding the island of Hawaii's broadband capacity.

Current market demands for concrete in Hawaii are primarily met through cement and asphalt imports. Research and development enabling innovative technologies in basalt concrete composition and delivery is an attractive and self-sustaining alternative to continued cement and bitumen imports.

There is also interest in and work being done on developing various basaltic concrete binding methods at the National Aeronautics and Space Administration, Hanyang University of Korea, Purdue University, American Society of Civil Engineers, and many other professional organizations. In addition to enabling three dimensional concrete printing technology, this work holds amazing potential for creating advanced manufacturing jobs and inexpensive building options in the State of Hawaii.

The proposed Pacific international space center for exploration systems sustainable concrete initiative is an important step toward realizing this potential, providing an investment in the future of Hawaii and its economy by offering a self-sufficient and in-situ source of concrete for local applications.

The purpose of this Act is to provide state funding to support the investigative stage of the Pacific international space center for exploration systems sustainable concrete initiative. This investigative stage will help identify appropriate binding methods and technologies; quantifiably test and validate the identified technologies in terms of durability, compressive strength, and other ASTM International certification standards; and help identify appropriate out-of-state partners and investors, as well as other extramural funding sources, for program development."

2. By amending section 2 to read:

"SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ \_\_\_\_\_ or so much thereof as may be necessary for fiscal year 2013-2014 to support the investigative stage of the Pacific international space center for exploration systems sustainable concrete initiative.

The sum appropriated shall be expended by the department of business, economic development, and tourism for the purposes of this Act."

3. By amending section 3 to read:

"SECTION 3. The Pacific international space center for exploration systems shall submit a report to the legislature on September 1 of each year, commencing on September 1, 2013, that includes:

- (1) An updated business plan regarding the aerospace technology research and development park project;
- (2) Details on any progress made toward the development of a world-class space center in Hawaii;
- (3) The development of technologies for basalt concrete composition and delivery and any effect on the level of cement and bitumen imports into the State;
- (4) The status of all working relationships with educational and research institutions, federal agencies, and local industry on the use of existing basalt resources in the State to identify, verify, and validate sustainable and in-situ concrete binders;
- (5) Details on any progress made toward the development of a robotic operator training and certification program, including program location, course and curriculum development, and when the program is expected to begin accepting students;
- (6) The level of private sector investment in aerospace and related industries, including the number and nature of any partnerships with private industry to facilitate state-based manufacturing and operations related to green energy technology;
- (7) The status of the memorandum of understanding with Hawaii Techworks and the east Hawaii community development corporation regarding the cultivation of a skilled local workforce to support planned manufacturing operations; and
- (8) A detailed statement of assets, liabilities, revenues, and expenses for the corresponding fiscal year ending June 30."

On motion by Representative McKelvey, seconded by Representative Choy and carried, Floor Amendment No. 12, amending S.B. No. 930, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE PACIFIC INTERNATIONAL SPACE CENTER FOR EXPLORATION SYSTEMS SUSTAINABLE CONCRETE INITIATIVE," was adopted, with Representatives Say and Tokioka being excused.

At 12:41 o'clock p.m., the Chair noted that Floor Amendment No. 12 was adopted.

Representative Johanson's written remarks are as follows:

"Mr. Speaker, I rise with reservations on SB 948, SD 1, HD 1. This bill expands the application of the GET and Use Tax and requires collection of taxes from sellers who engage or continue within the state in business. In essence, the bill is designed to tax internet transactions conducted by businesses with a physical presence in Hawaii. My primary concern is that this bill is a functional tax increase, which will increase the cost of living for residents. Additionally, this bill may have the unintended consequence of ending affiliate relationships in the state and could lead to local businesses losing revenue. For these reasons, I am voting with reservations."

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Cheape rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Thielen rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, a no vote and just a reminder to our colleagues that this could be potentially the biggest tax increase in contemporary history. Thank you."

Representative Fale rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Fukumoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 948, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TAXATION," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Fale, Fukumoto, McDermott, Thielen and Ward voting no, and with Representatives Say and Tokioka being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1472) recommending that S.B. No. 1361, SD 2, HD 1 pass Third Reading.

Representative Johanson's written remarks are as follows:

"Mr. Speaker, I rise with reservations on SB 1133, SD 2, HD 2. This bill removes the exemption for liquid dietary supplement containers in amounts greater than one ounce from the deposit beverage container program. Senior dietary supplements, such as Ensure, now seem to be exempted. I do, however, worry that this bill will exacerbate the cost of living for our residents, and may in some cases, have the most impact on those who are least equipped to handle increased fees."

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Fale rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Cullen rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 1133, SD 2, HD 2, entitled: "A BILL FOR AN ACT RELATING TO THE DEPOSIT BEVERAGE CONTAINER PROGRAM," passed Third Reading by a vote of 46 ayes to

3 noes, with Representatives Fale, Fukumoto and McDermott voting no, and with Representatives Say and Tokioka being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1474) recommending that S.B. No. 515, SD 2, HD 1 pass Third Reading.

Representative Saiki moved that the report of the Committee be adopted, and that S.B. No. 515, SD 2, HD 1 pass Third Reading, seconded by Representative Awana.

Representative Jordan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. Representative Takai's written remarks are as follows:

"Mr. Speaker, I rise in support of this measure.

"As many of us know, the United States has had a tumultuous history in the Middle East over the past three decades. This history cannot be ignored. The Persian Gulf War, Operation Desert Storm, Operation Iraqi Freedom, Operation Enduring Freedom, Operation New Dawn, the Global War on Terrorism, Homeland Defense and Operation Noble Eagle were the wars of this generation and its veterans and heroes must be honored.

"Hawaii has already dedicated the Korean-Vietnam War Memorial on the grounds of the State Capitol to remember those in Hawaii who sacrificed their lives for others during these wars. For some of us, these wars directly affected our generation or our parents' generation. This memorial holds special significance for those who can remember what it felt like during those times of hardship. We could relate to our Korean and Vietnam War veterans who gave their lives to serve their country; they were our classmates, our relatives, our peers and our friends. We remember who they were. We remember their stories in the news, and the memorial serves both as tribute to their sacrifice, tribute to the wars' living veterans, and as a beacon of hope for us.

"The veterans and families of these Middle East wars also deserve to have the same tribute because they too sacrificed everything for our nation. After 9/11, our security was shattered, our country broken, and we mourned for those lost. Though we in Hawaii are separated from the continental US, distance did not separate our collective grief and resolve to prevent another 9/11 attack from occurring. Local men and women did not merely endure, but instead joined the armed services intent on rebuilding what our nation lost, and left home to enter lands of uncertainty and conflict. Service members from Hawaii gave and lost their lives. Though memorializing their sacrifice cannot possibly express the extent of gratitude of our state, it serves to remind veterans and family members that we do not forget those who have sacrificed everything.

"This memorial established for the veterans of the Persian Gulf War, Operation Desert Storm, Operation Iraqi Freedom, Operation Enduring Freedom, Operation New Dawn, the Global War on Terrorism, Homeland Defense, and Operation Noble Eagle would honor this generation's heroes, veterans, and military families, and would remind them that there is hope in loss, that there can be honor in death, and that freedom does not come without a price.

"For these reasons, I support this measure and urge my colleagues to do the same. Thank you."

Representative Cabanilla rose to disclose a potential conflict of interest, stating:

"Ruling on a potential conflict, Mr. Speaker. I'm a veteran in one of these conflicts. Thank you," and the Chair ruled, "no conflict."
