### ORDER OF THE DAY

#### SUSPENSION OF RULES

On motion by Representative Saiki, seconded by Representative Awana and carried, the rules were suspended for the purpose of reconsidering action previously taken in disagreeing to amendments made by the Senate to a certain House Bill. (Representatives Carroll, Oshiro and Ward were excused.)

#### RECONSIDERATION OF ACTION TAKEN
