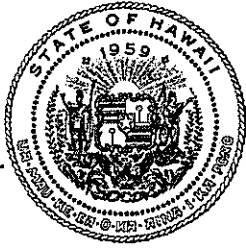

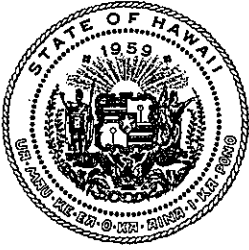
Chair Dela Cruz, Vice Chair Slom and Members of the Senate Committee on Economic Development, Government Operations and Housing.
