In response to your questionnaire, I submit these comments on my nomination to the state Civil Defense Advisory Council, which is part of GM581.

Why do you wish to be a member of the Civil Defense Advisory Council: I have long had an interest in the resilience of our community and in its Civil Defense response and hope to serve my community by bringing decades of experience in the Islands to the Council.

Qualifications, statement of skills: I have participated in numerous Civil Defense briefings and interviews over nearly 40 years as a newspaper reporter. I worked closely with Civil Defense authorities during catastrophic events like volcanic destruction at Kalapana on Hawai'l and Hurricanes Iwa and Iniki on Kaua'i. I have taken several FEMA training courses as part of my volunteer work with the Kaua'i Civil Defense Agency. I serve as vice-chair of the Board of Directors of the Kaua'i Island Utility Cooperative, which is directly involved in community emergency response to climate events. And as a science writer and communications consultant, I have the training to analyze strategies and situations relating to civil defense matters.

What do you hope to accomplish during your term of service? Our island community faces a range of threats related to weather, climate, international tensions, food and fuel supply disruptions and other issues. I am familiar with many of these issues, and as someone who has lived or worked on each of the Hawaiian islands, I believe! bring a mature, seasoned perspective to helping ensure our community is well protected. I have no other mission than to represent my community competently and fairly.

<u>Conflicts:</u> I imagine a conflict could arise over my involvement as a Civil Defense volunteer, although I have raised that issue at both the state and county levels and been assured there are no concerns. If a conflict did arise, I would remove myself from the CD volunteer rolls if necessary. I do not anticipate conflict regarding my professional life as a communications consultant or as an elected member of the KIUC electric cooperative board.
