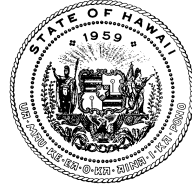

1 **Department's Position:** The Department of Health supports the nomination and confirmation
2 of Mr. Tito Villanueva to the Kauai Subarea Health Planning Council (KCSAC).

3 **Fiscal Implications:** None

4 **Purpose and Justification:** The purpose is for the consideration and confirmation to the
5 KCSAC, Gubernatorial Nominee, Mr. Tito Villanueva.

6 For 20 years, Mr. Villanueva served and continues to serve as an Emergency Medical
7 Technician (EMT) with American Medical Response (AMR) as well as a part-time Fire
8 Fighter/EMT with the ITT Corporation. He is also AMR's Operations Manager for the County
9 of Kauai. Prior to his career in emergency medical services, he was an Immigrant
10 Employment Core Services Manager with Kauai Economic Opportunity. He was also a
11 Corpsman and Lead Petty Officer Field Medic with the United States Navy.

12 In addition to being certified as an EMT, Mr. Villanueva is certified as a Fire Fighter I
13 and II, and Haz-Mat Awareness and Operations. He is certified by the American Heart
14 Association BLS Training Faculty, CPR Instructor, Car Seat Safety Technician, and
15 Community Emergency Response Team Instructor.

1 Mr. Villanueva was a Star of Life recipient, past Hawaii State EMT of the Year, member
2 of the Filipino Chamber of Commerce, and past Executive Board Member of the Kauai Filipino-
3 American Jaycees.

4 He has a Bachelor of Science in Business Management from the University of Phoenix.
5 He is also a graduate of the EMT Program at Kapiolani Community College.

6 We ask for your support on the confirmation of Mr. Tito Villanueva to serve on the Kauai
7 Subarea Health Planning Council.
