Hi, I'm Lisa Grandinetti, I'm a senior at Mililani High School, I am your constituent, and I ask that you approve HB 1133 as is to repel the PLDC.

Living in Mililani, it's easy to understand the benefits and detriments of development being in the middle of it. As one of the first master planned communities in Hawaii, Mililani set the example for a somewhat more responsible mode of development.

But the extent to which development has expanded is both unrealistic and unsustainable. This is the point that it is necessary to level off the development of our islands and shift to a mode of thinking where solutions can be made for the problems of existing development.

Despite this dire and obvious need, we are doing precisely the opposite. This bill, as you know, gives the PLDC the access to virtually any land it pleases. The possibility that this power will be used to expand agriculture, a more favorable option, is unlikely and the implications of this broadly worded bill are inescapable.

A privately conducted project that hits close to home is Koa Ridge. After decades of justified and logical resistance by the public, Koa Ridge, just one of countless anti-agriculture development plans, was approved. Koa Ridge will create an entire community of thousands of homes that central Oahu is just not equipped for. All surrounding areas, including mililani, will be forced to endure the effects of this development. This is a story that people all around the islands share and we have come together against Act 55 to save our future. Giving private entities control over public land will lead to even more stories just like Koa Ridge and we will continue to fight until the PLDC is repealed to prevent such events from unfolding.

If HB 1133 is not approved, the PLDC will result in a lifetime of recovery efforts on the part of my generation. Although I would be completely willing to do this, I'd rather focus my efforts on a more positive rather than reactive movement. Save us from this terrible fate, let us dedicate our lives to bettering our lands instead of restoring them from the results of this bill, please, approve HB 1133 and repeal Act 55.
