Re: H.B. 1260, H.D. 1, Relating to Agriculture

The Department appreciates the intent of H.B. 1260, H.D. 1, and provides the following information and comments for your consideration.

H.B. 1260, H.D. 1 expands the definition of "agricultural commodity" found in Section 237-24.3(1), Hawaii Revised Statutes. The bill would result in amounts received from the loading, transportation, and unloading of several animal products, milk, poultry, eggs, poultry meat, and aquaculture or aquaponic products being exempted from Hawaii's General Excise Tax, in addition to amounts received from the loading, transportation, and unloading of those items already considered agricultural commodities under the statute.

The Department notes that there is no definition of the terms "aquaculture products" or "aquaponics products" included in Chapter 237 or in Section 147-1, Hawaii Revised Statutes, which may make this expansion of the existing exemption difficult to administer. The Department suggests adding clarification to this portion of the bill to ensure that amounts received from the loading, transportation, and unloading of the intended products are included.

Adds milk, poultry eggs, poultry carcass, poultry meat, beef, beef carcasses, goat meat, goat carcasses, lamb meat, lamb carcasses and aquaculture and aquaponic products to be consumed in the State to GET exemption for the loading, transporting, or unloading of agricultural commodities shipped into the State. Effective July 1, 2013. (HB1260 HD1)

Chair McKelvey, Vice Chair Kawakami and Members of the Committees:

My name is Alan Gottlieb, and I am the Government Affairs Chairperson of the Hawaii Cattlemen's Council. The Hawaii Cattlemen's Council, Inc. (HCC) is the Statewide umbrella organization comprised of the five county level Cattlemen's Associations. Our 130+ member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of approximately 25% of the State's total land mass.

The Hawaii Cattlemen's Council <u>strongly supports</u> HB 1260 HD 1 to the Agricultural Commodity Definition <u>with some proposed changes</u> (our proposed changes are in bold and double underlined below):

<u>Cattle</u>, Beef and beef carcasses; <u>Goats</u>, goat meat and goat carcasses;

Lambs, lamb meat and lamb carcasses; Sheep, sheep meat
and sheep carcasses; Hogs, pork and pork carcasses; milk;
eggs; or Chickens, poultry meat and poultry carcasses to
be consumed in the State, whether processed in the State
or imported; and

(B) Aquaculture or aquaponic products to be consumed in the State, whether processed in the State or imported;

This is an issue of parity. All other agricultural commodities have this G.E.T. Exemption. The reason we ask that livestock and meat, milk eggs, poultry, aquaculture, etc. be included in the definition is so like other Agricultural commodities, we will be exempt from the State's General Excise Tax.

Over the years we have come across definitions of agriculture commodities which have not included livestock, or the meat from livestock agriculture, milk, eggs, poultry and aquaculture/aquaponics, etc. and have sought to have those corrected so they are included. The problem is that there are so many different

places where there are definitions, we seem to need to deal with them one by one as they come to our attention. In the past the legislature has always been very supportive on this very common sense issue.

Young Brothers has provided us with information quantifying how much this will cost the State of Hawaii in lost General Excise Taxes. For 2009, that amount was just \$6,100 for General Excise taxes they collected on items which would be affected by this amendment, a very small amount for the State but a big amount for local livestock producers. In the future, if we can help improve the economics of livestock production in Hawaii, we hope to increase our production, and help the State with its agricultural self sufficiency and improve our food security.

We appreciate this opportunity to provide testimony on this matter.

Ulupono Initiative Strongly Supports HB 1260 HD 1, Relating to Agriculture

Dear Chair McKelvey, Vice Chair Kawakami and Members of the Committee:

My name is Kyle Datta and I am General Partner of the Ulupono Initiative, a Hawai'i-based impact investment firm that strives to improve the quality of life for the people of Hawai'i by working toward solutions that create more locally grown food, increase renewable energy, and reduce/recycle waste. Ulupono invests in projects that have the potential to create large-scale, innovative change.

Ulupono strongly supports HB 1260 HD 1, which adds to the definition of agricultural commodities exempt from the General Excise Tax (GET). We would also request that HRS section 237-24.3 Section 1, Subsection A, be amended to read "Cattle, Beef and beef carcasses; Goats, goat meat and goat carcasses; Lambs, lamb meat and lamb carcasses; Sheep, sheep meat and sheep carcasses; Hogs, pork and pork carcasses; milk; eggs; or Poultry, poultry meat and poultry carcasses to be consumed in the State, whether processed in the State or imported; and." This would reduce the cost for milk, eggs, poultry, beef, goat, lamb, sheep, aquaculture and aquaponics products to be consumed in the state by exempting these activities from the GET.

The Legislature earlier exempted agricultural commodities from the GET and this bill would amend that definition (which already includes fruits and vegetables) so that more locally produced foods in the state, will be eligible for the GET exemption. Ulupono is concerned that the GET multiplies along the food supply chain, increasing the price which makes local food less competitive than imports. These actions would support our local food industries.

We believe that working together we can help produce more local food, support an economically strong homegrown agriculture industry, which strengthens our community with fresh, healthy food. Thank you for this opportunity to testify.

HFBF supports of HB 1260, HD1 which adds beef and beef carcasses, goat meat and goat carcasses, lamb meat and lamb carcasses, sheep meat and sheep carcasses, milk, poultry eggs, poultry carcass, poultry meat, and aquaculture and aquaponic products to the definition of "Agricultural Commodity" exempt from the GET for loading, transporting, and unloading of agricultural commodities under Section 247-24.3 (1), Hawaii Revised Statutes. In addition, we request that cattle, goats, lambs, sheep, hogs, pork and pork carcasses and chickens also be added to the definition of "Agricultural Commodity".

Currently, Section 147-1, Hawaii Revised Statues, defines "agricultural commodity" as fresh fruits and fresh vegetables of every kind and character, whether or not frozen or packed in ice, whether produced in the State or imported, nuts, and coffee, whether cherry or parchment, or green beans, which have been produced in the State, and raw unprocessed honey, whether produced in the State or imported.

HFBF believes that cattle, beef and beef carcasses, goats, goat meat and goat carcasses, lambs, lamb meat and lamb carcasses, hogs, pork and pork carcasses, sheep meat and sheep carcasses, milk, poultry eggs, chickens, poultry carcasses, poultry meat, and aquaculture and aquaponic products are also agricultural commodities and should added to the definition in Section 147-1 so that these agricultural commodities receiving the exemption provided in Section 247-24.3 (1)

My name is Jason Moniz and I am President of the Hamakua County Farm Bureau. Hamakua is a large agricultural district with one of two dairies remaining in the State, 24% of Hawaii Islands beef cattle grazing lands and the largest beef harvest/processing plant in the State.

This Bill proposes to places the livestock and aquaculture commodities on an even playing field with other agricultural commodities that already have this GET exemption in place. The transportation of breeding animals, market animals, and livestock and aquaculture products (eggs, milk, meat) are significant costs to the marketing of livestock, aquaculture and The legislature recognized previously that their products. assistance to agriculture producers in the form of removing the GET for transportation of agriculture products was an important support needed to promote Hawaii's agriculture and food security. Unfortunately the definition used left out livestock and aquaculture, significant and important sectors of Hawaii's agriculture. Particularly in the case of livestock shipping, fees are already very high in relationship to their value due to their size and space required to contain them during shipment.



Chair McKelvey, Vice Chair Kawakami, and Members of the House Consumer Protection and Commerce Committee:

Young Brothers, Limited (*Young Brothers*) supports House Bill No. 1260, House Draft 1 (*HB1260 HD1*).

HB1260 HD1 proposes to expand the types of agricultural commodities exempt from the general excise tax on amounts received for loading, transportation, and unloading, to include milk, poultry eggs, poultry carcass, poultry meat, beef, beef carcasses, goat meat, goat carcasses, lamb meat, lamb carcasses and aquaculture and aquaponic products to be consumed in the State, whether imported into or processed within the State.

In the context of its intra-state water transportation services, Young Brothers has been providing local farmers and ranchers with a discount for shipments of island agricultural products for over 20 years. Today, Young Brothers offers a discount of 35 percent for full container loads of island agricultural products and a discount of 30 percent for all other island agricultural product shipments. These discounts applicable to shipments of island agricultural products are consistent with the State's policy of promoting locally grown produce. We refer you to Haw. Const. of 1993, art. XI, § 3, which provides in relevant part:

The State shall conserve and protect agricultural lands, promote diversified agriculture, increase agricultural self-sufficiency and assure the availability of agriculturally suitable lands. The legislature shall provide standards and criteria to accomplish the foregoing.

Young Brothers continues to support measures that promote the State's agricultural and economic diversity and sustainability.
