The resources are still abundant on our islands and DOCARE does an excellent job at protecting the resources however, the size of their staff makes it hard for them to cover entire islands. The specialty skills of a DOCARE officer that is utilized to preserve and protect the resources is vital conservation and to provide for the future of our resources that many of us use for sustenance. I believe to have a larger budget to provide for more Civil state jobs in this particular division would be a step in the right direction for creating more solutions to many past problems.
