House Bill 1412 proposes to require the Department of Land and Natural Resources (Department) to accommodate mooring of native Hawaiian canoes owned by nonprofit entities and used for educational purposes in small boat harbors, as practicable. The Department notes that the Senate amended the companion measure Senate Bill 1371, by deleting the phrase "insofar as practicable" from line 9, page 2, because it may severely limit the availability of moorings. **The Department has no objection to this amendment.**
