#### HOUSE BILL NO. 1421 RELATING TO ORGANIC AGRICULTURE

Chair Wooley and Members of the Committee:

Thank you for the opportunity to testify on House Bill No. 1421. The purpose of this bill is to require the DOA to establish a combined organic agricultural mobilization program to provide affordable long-term leases to farmers to establish small, organic farms. It also authorizes the PUC to establish preferential utility rates for participants of the program and makes an appropriation for an administrative position to oversee the program. The department respectfully opposes this bill as we believe it is unnecessary.

The existing land leasing programs within the department of agriculture (department) already have the ability to lease lands to organic farmers, provided that they qualify as bona fide or new farmers. Any potential lessee has the opportunity to identify and bid on any vacant parcel under our jurisdiction. The department strives to promote all forms of agriculture in a fair and consistent manner and feels that providing special considerations to any one group conflicts with this mission. Additionally, the language explicitly allowing the "construction of farm dwellings,…renewable energy improvements, and necessary infrastructure on the farm land" directly conflicts with provisions of our leases, setting up potential legal actions against the State. these actions are not prohibited, their construction must be carefully evaluated for appropriateness and need, and approved by the Board of Agriculture.

We offer no comments on the proposed roles of the Public Utilities Commission and the High Technology Development Corporation. We also question the confusing method of funding being proposed.

**TITLE:** Relating to Organic Agriculture

Chair Wooley and Members of the Committee:

#### **DESCRIPTION:**

This measure proposes, among other things, to have the Public Utilities Commission ("Commission") provide preferential utility rates for farmers participating in the Combined Organic Agricultural Mobilization Program ("Program") to be established by the Department of Agriculture. Eligible Program participants apply to a public utility for preferential utility rates, and then the public utility receiving applications must propose preferential rates to the Commission "for approval." Finally, H.B. No. 1421 states that all preferential rates approved by the Commission "shall be subsidized" by rates charged to other customers.

#### **POSITION:**

While the Commission supports policies that encourage and support agricultural activities in the State, it cannot support any measure that would establish a discriminatory regulatory practice.

#### COMMENTS:

The Commission cannot support legislation that intends to have utility customers unfairly shoulder the burden of costs created by a single customer class. Section 4 of this bill specifically says that all Commission-approved preferential rates "shall be subsidized by the rates charged to other customers of the utility, if necessary, as determined by the [Commission]."

The use of preferential rates places an unfair burden and a hidden "tax" on the utility ratepayer who does not qualify for the preferential treatment. This bill also highlights potable water as a service area where preferential rates should be provided for Program participants. Many of Hawaii's water utilities are very small companies with no economies of scale, thus preferential rates would place a significant burden on other water utility customers.

A main objective of the Commission is to stabilize and reduce cost for all ratepayers by ensuring efficiently run utilities. Off-peak rates, a form of rate reduction, should be offered to any ratepayer that can make the electric system more efficient during periods when electricity or usage is low and resources must be curtailed. Such a focus, rather than preferential rates, could be more beneficial to all ratepayers.

Finally, the Commission is concerned that this measure will be a significant burden on the Commission's staff and resources, and would further detract from its priorities to stabilize and reduce costs for all ratepayers in a fair and equitable way.

We strongly support this bill to keep the 'aina sustainable and our ecosystem balanced and PARTICULARLY to protect and perpetuate our natural genetic lines, richness of soil, fauna, plants, animals, foods as nature intended it in "biodiversity." The people of the outer islands are concerned with the direction of Genetic engineering practices taking over these island lands, an approach to farming and practices that are invasive, toxic and not ultimately sustainable for the ecosystem. Do not believe the myth that igenetical engineering will feed more people in the world and be supportive of farmers. We have more endemic species for this than almost anywhere else in the world to learn from and grow with.
