House Bill 1424 proposes to require the Department of Land and Natural Resources (Department), in consultation with the Hawaiian Islands Land Trust (HILT) and notwithstanding Board of Land and Natural Resources (Board) approval, to engage in efforts to acquire the parcel of land located at Lipoa Point, identified as tax map key 2-4-1-001-010-0000. The bill also proposes an appropriation to fully or partly fund the acquisition. **The Department supports the intent of this measure, provided the appropriation does not negatively impact the priorities of the Administration's Biennium Budget request.**

In brief discussions with HILT, the Department has learned that the owner, Maui Land and Pineapple Company, Inc., is a willing seller and that HILT is hiring an appraiser to provide a letter of appraisal and eventually a full appraisal of the subject property and intends to apply for State grant-in-aid to fund the due diligence process. Notwithstanding the Board's approval under Section 173A-5(i), Hawaii Revised Statutes (HRS), the Department is able to continue discussions with HILT regarding the acquisition of the subject property pursuant to the regular due diligence procedures of the Department, the approval of the Board under Section 171-30, HRS, and the approval of the attorney general required under Section 107-10, HRS. The Department supports acquisition provided that the designated management program has the capacity to manage the property for its cultural and recreational values.

The Department presently provides funding to Maui Land and Pineapple Company, Inc., for conservation and restoration actions in its mauka watershed forests through grant agreements from the Natural Area Partnership Program and the Forest Stewardship Program.

Grew up at the the Baldwin packers pineapple camp in Honokahua Maui. My dad worked as a utility driver for the pineapple company. My mom worked as at Napili Kai Beach Club. I am the second oldest child of the three brothers and three sisters. Our father taught us how to live off the land and ocean. We fished by throw newt and Hukilau from Honokohau to Oluwalu. We used to the boat ramp at Honolulu bay to launch our boat with the nets and hukilau. Those days we were allowed to catch fish and camp at Honolulu Bay and Kulaokaea (Lipoa Point) as a fishing family we camped and fished almost every weekend to put food on our table and to share with other family members. This is a cultural part of our heritage that our father instilled in us. As a board member of the Save Honolulu Coalition, a 501c3 non profit organization, I humbly ask for your support of bill HB1424. We are working with Hawaiian Islands Land Trust, Aha Moku, Maui Land and Pineapple, and local government to create a win win solution. Please do what is right to save Kulaokaea (Lipoa Point) and Honolulu bay for Kupuna's past and present and our community.

Thank you for the opportunity to testify in support of this important measure. The purpose of this measure is to appropriate general obligation bonds for the Department of Land and Natural Resources, in consultation with the Hawaiian Islands Land Trust, to engage in efforts to acquire the parcel of land located at Lipoa Point.

The Maui County Council has not had the opportunity to take a formal position on this measure. Therefore, I am providing this testimony in my capacity as an individual member of the Maui County Council.

I support this measure for the following reasons:

1. By Ordinance 4004 (2012), the Maui Island Plan was adopted as part of the Maui County General Plan. The Maui Island Plan establishes, for the first time, urban and rural growth boundaries on the island of Maui. The Maui Island Plan also identifies areas that should be permanently protected because of their significant environmental, ecological, cultural, and recreational value, and because degradation of the resource would result in an irretrievable loss. During its deliberations on the Maui Island Plan, the Council heard from hundreds of testifiers pleading with the Council to identify Lipoa Point for permanent protection. Unfortunately, the Council was only comfortable identifying the immediate coastal areas of Lipoa Point and Honolua Bay for protection because these lands are already in the State Conservation District. The Council did not want to identify the other lands at Lipoa Point and Honolua Bay for permanent protection because of the potential devastating consequences of more than 1,600 retirees of Maui Land & Pine whose pensions may be jeopardized by the potential devaluation of the property.
2. Due to economic conditions, Maui Land & Pine stopped pineapple operations in 2009 and was forced to lay off workers. Because of the reduction in active employee participation in the pension plan, the company posted approximately 1,400 acres in West Maui as collateral in April 2011. The land remains collateralized today. When the company ended its golf operations in March 2011, the loss of additional active employees participating in the pension plan triggered the requirement of additional security. Maui Land & Pine is relying on Lipoa Point and over 5,300 acres mauka of Honolua to secure the additional unfunded retirement liability.

3. Since 2007, the Mayor and Council have consistently pledged \$1 million for the acquisition of land at Lipoa Point, but we cannot do it alone. We need partners from the State and Federal Government, and from concerned community groups to ensure the preservation of Lipoa Point in perpetuity.

For the foregoing reasons, I support this measure.

Comments: My Name is John Carty and I live on Maui in the moku of Ka'anapali. I'm the v.p. of the Save Honolua Coalition. Our mission statement is to maintain open space, public access, and revitalize the ahupua'a of Honolua through community based management utilizing Hawaiian cultural practices and values. We support HB 1424. We are working together with Maui Land & Pineapple, Hawaiian Islands Land Trust, Aha Moku, the Maui County Council, and Mayor Arakawa. There is a sense of urgency. Many factors are coming together to make now our best chance to Save Honolua and create a win-win situation for all involved. The unstable financial condition of the land owner, Maui Land & Pineapple Company looms over the open space of Honolua like a dark cloud. About 5 1/2 years ago MLP withdrew plans for development at Honolua after overwhelming testimony from the community including over 16,000 physical signatures to the Save Honolua petition calling for the preservation and acquisition of this area. Since then, we have been exploring different ways to preserve the land while taking steps towards cleanup and revitalization with the land owner and various groups. It is a scary thought of what would happen if MLP went under and we had to deal with the highest bidder. Lets make a deal now with a willing landowner. There are many reasons why it is crucial to Save Honolua with a land trust. And while it is enough to do it for her own sake because she is Honolua, I will mention more. First: Revenue. Honolua is what tourists love and it is the star attraction in West Maui where the majority of high end luxury hotels on Maui are. Its snorkeling, open space, and wild beauty are the essence of what brings the tourists along with their money to our State. During the summer and other peak days, our studies conclude that over 1000 people access Honolua Bay by land and sea. Second: Environment. Honolua Bay is a State Marine Life Conservation District and the reef is dying fast. According to the most recent DLNR survey, in 1995 there was 45% coral cover in the Bay. 10 years later it was less than 9% That's 45 down to 9. After the latest round of development in our Ahupua'a several years ago, events like this started happening (show picture of mud flow). This runoff has been devastating. We must make certain that this does not happen again. Third: Community. Honolua is beloved by the people of Maui for reasons too many to mention. Surfing is a big one. It is known as "The Bay" and loved world wide by surfers for its perfect shape. Our West Maui shoreline is filled with Hotels, Restaurants, and private homes from

Pua'mana all the way to Kapalua. Honolua is the first open space and the playground and sanctuary for our people. And fourth, the most important reason, is culture. The harm done to our host culture and its people by development and western land practices is unimaginable. We can, through this bill, Save this area so that future generations of Hawaiians can connect to this sacred land of their ancestors. In 1976 the Hokule'a launched from Honolua on her maiden voyage. There are many important cultural sites in the area including heiau, burials, holua slide, kings trail, and more. I am lucky to be friends with a few kupuna from the area and I wish they could be here today to tell you the deep spirituality and sacredness of honolua. And maybe they would tell you what they have told me... "We are counting on you to save it."


