Testimony in **Support** of H.B. 14 H.D. 1, Relating to Early Childhood Education By GG Weisenfeld, Director

Chair Luke, Vice-Chair Nishimoto, Vice-Chair Johanson, and Members of the Committee:

Good afternoon. I am GG Weisenfeld, Director of the Executive Office on Early Learning (EOEL). EOEL is in support of House Bill 14, House Draft 1.

The purpose of this bill is to make kindergarten mandatory for a child who will be at least five years of age on or before July 31 of the school year. The bill further requires the Department of Education, in collaboration with EOEL, to develop a statewide individualized kindergarten readiness system and establish an individualized kindergarten readiness assessment system.

EOEL supports the provision to make kindergarten mandatory.

Across the nation, most school districts require that a child be five years old before entering kindergarten or become five in the first month of school. In 2012, 39 states and the District of Columbia had cutoff dates of September (usually the first day of school) or earlier.

As we work to implement an early learning system in Hawaii, it makes sense to have mandatory kindergarten to promote the continuity of children's experiences from prekindergarten to kindergarten. While most children enroll in kindergarten, some families do not feel compelled to send their children to school on a consistent basis because it is not mandatory. Without the skills that can be gained through a kindergarten experience, these children may have to play catch up with their peers in first grade. This may leave the child feeling discouraged and put them in a position to fall further behind.

With the adoption of the Common Core State Standards for kindergarten to grade 12, it is even more important now that kindergarten be made mandatory so Hawaii's children can meet the academic requirements of K-12.

EOEL also supports the requirement of this bill that EOEL cooperate with the Department of Education to develop a kindergarten readiness assessment system. As EOEL develops a prekindergarten program for four-year-olds, it is important that the School Readiness and Early Childhood Education programs align with the DOE kindergarten program. A kindergarten readiness assessment system is an important part of achieving this alignment.

**PURPOSE:** The purposes of H.B. 14, H.D. 1 are to amend the compulsory education law to make kindergarten mandatory; develop a statewide individualized kindergarten readiness tool; establish an individualized kindergarten readiness assessment process; and appropriates funds.

**DEPARTMENT'S POSITION:** The Department of Human Services (DHS) supports the intent of this bill and defers to the Department of Education and the Executive Office on Early Learning on the implementation of its provisions.

Act 169, Session Laws of Hawaii 2013, established the existing child care assistance program, called Preschool Open Doors, as the statewide school readiness program to be administered by the Department of Human Services.

The Preschool Open Doors (POD) program serves low- to moderate-income families whose late-born children are affected by the change in kindergarten entry age

in the 2014-2015 school year or whose children will be eligible for kindergarten in the following school year.

Requiring that kindergarten attendance be mandatory under the compulsory education law would require children enrolled in the POD program to attend kindergarten in the following year and will promote continuity of the children's early learning experiences and thus maximizing the value of the POD program. Children will have the needed school-readiness skills they experienced in a preschool setting through the POD program and will be ready to apply those skills in kindergarten.

The Honorable Chair Sylvia Luke and Members of the Committee:

The Hawaii State Teachers Association (HSTA) wholeheartedly <u>strongly supports</u> <u>H.B. 14, HD1, Mandatory Kindergarten.</u>

HSTA is the exclusive representative of more than 13,500 public and charter schoolteachers statewide. As the state affiliate of the 3.2 million members of the National Education Association, HSTA believes that kindergarten should be mandatory as well as adequate funding should be provided by the state so that kindergarten education will be available to all five year olds.

In President Obama's state of the union address, he referred to the proliferation of pre-kindergarten programs. As such, kindergarten may no longer be the primary bridge between home and formal education. However, it still serves as an important transitional function as kindergarteners are expected to lean basic academic and social skills that prepare them for the demands of first and subsequent grades. In order to ensure that this expectation is met, kindergarten attendance should be mandatory, and Hawaii should offer a publicly –funded, quality kindergarten program.

HSTA supports full day mandatory Kindergarten programs. If early childhood education is a priority, then schools should have mandatory kindergarten in our compulsory attendance laws before a new project is started.

HB 14, HD 1: Relating to Early Childhood Education.

Chair Luke, Vice Chair Nishimoto, Vice Chair Johanson and Members of the Committee: HB 14, HD 1 makes attendance at kindergarten mandatory, develops a statewide individualized kindergarten readiness tool, establishes an individualized kindergarten readiness assessment process, and appropriates funds for the process.

Hawaii P-20 supports this bill. As an organization that works in partnership with the Executive Office on Early Learning, the Hawaii Department of Education and the University of Hawaii, Hawaii P-20 works to improve the educational pipeline and facilitates seamless educational experiences across systems. Full-day kindergarten is essential to create the educational, socioemotional and physical building blocks to success in latter years in the K-12 education system and beyond.

In particular, Hawaii P-20 strongly supports the creation of an appropriate individualized kindergarten readiness assessment system. Currently, schools create or adopt their own assessments in order to survey incoming students' readiness for school. Many of these tools are not developmentally appropriate, cumbersome to administer, and expensive. Moreover, they do not provide any uniform data to the Hawaii Department of Education about children's readiness or consistent feedback to early learning programs about their preparation of children or feedback to parents and families about their child's learning and development. It is absolutely essential that the state begin to collect data about individual child readiness for kindergarten in order to improve the preparedness of children, aid teachers in providing differentiated learning techniques, and for longitudinal studies about education outcomes.

Furthermore, we strongly support the request for the funding of an appropriate kindergarten assessment tool, as well as the ongoing training necessary on the chosen tool. The Hawaii Department of Education cannot be expected to implement a new statewide assessment system without adequate funding. The proposed amount of \$870,000 for the first year of implementation and training is appropriate; on-going annual costs should amount to approximately \$405,000 for the four personnel and annual subscription costs for a kindergarten assessment tool. Chair Luke, Vice Chairs Nishimoto and Johanson, and Members of the Committee:

The Chamber of Commerce of Hawaii ("The Chamber") **supports** HB 14, HD1 Relating to Early Childhood Education.

The Chamber is the largest business organization in Hawaii, representing over 1,000 businesses. Approximately 80% of our members are small businesses with less than 20 employees. As the "Voice of Business" in Hawaii, the organization works on behalf of members and the entire business community to improve the state's economic climate and to foster positive action on issues of common concern.

The Chamber believes that this measure must be in place to properly equip Hawaii's youth with important life skills. The Chamber strongly believes that children need to attend kindergarten or risk following behind their peers. While non-attendance is not a large segment of the population, it is important that many children attend kindergarten. Also as it is voluntary, sometimes children who are not ready to advance to the next level are allowed to move forward.

On a broader level, early childhood is critical because brain development takes place by age five. We believe it's imperative to begin investing early in a child's life, when the brain is in this state of tremendous growth potential. In 2008, the Hawaii Economic Benefits Study of early education for Hawai'i showed that for every \$1 Hawai'i invests in a quality four-year early learning program, the state will receive a return of \$4.20. This is not only about return of investment but in providing for our employees and their children.

Chair Luke, Vice Chair Nishimoto, Vice Chair Johanson, and Members of the Committee on Finance

My name is Donald Young. I am the Dean of the College of Education at the University of Hawai'i at Mānoa.

On behalf of the College of Education, I support HB 14 HD 1. While we continue to struggle with how to provide quality early learning opportunities for all young children, it remains an anomaly that we do not require Kindergarten attendance. It is true that in Hawai'i a very large number of families voluntarily enroll their children in Kindergarten. However, leaving early learning to chance is unacceptable if we truly intend to create a literate, productive workforce and ensure all children have access to life opportunities they may wish to achieve.

HB 14 HD 1 calls for the early learning system to facilitate the transition to kindergarten of children in the program. I wish to respectfully remind the Committee that the College of Education has considerable faculty expertise in developing early learning systems, including assessment protocols and instruments appropriate for young children, that could contribute to fulfilling the intent of this part of the bill.

I wish to also point out that several years ago the Hawaii Educational Policy Center (HEPC) engaged in a statewide effort focused on the transition of young children into Kindergarten. In addition to the research conducted, there were two instruments developed, one assessing the readiness of groups of children to enter Kindergarten, and another assessing the readiness of schools to accept and provide quality educational services for them. I respectfully suggest that should HB 14 HD 1 pass that we re-look and build upon the earlier HEPC work rather than assuming that we are starting from scratch. My name is Phyllis Ida and I am a retired DOE Special Educator, and the former 619 Coordinator for the Windward District. I also over see the grant administration for the Windward District P-3 Demonstration Project that focuses on keiki reading on grade level by third grade, providing model program of seamless early learning experiences from early childhood programs through elementary school for young children in the Windward District.

I am writing this testimony to ask for your support of HB14 HD1 relating to early childhood education, as it amends the compulsory education law to make kindergarten mandatory; develops a statewide individualized kindergarten readiness tool; and establishes an individualized kindergarten readiness assessment process.

The Windward P- 3 Grant & its Demonstration Project appreciates and acknowledges the need for this particular measure in order for the Executive Office on Early Learning to proceed with its educational plan for Hawaii's young children.

There is a need for this particular measure in order for the state to proceed with its educational plan for Hawaii's young children.

The Hawaii State School Readiness Assessment (HSSRA) for the 2012 -2013 School Year estimates that approximately 43% of Hawaii's keiki entered kindergarten *without preschool experience*.

If a child does not arrive at kindergarten ready to learn because of his/her lack of or access to quality early learning opportunities, he/she will most likely struggle to keep up.

A lack of school readiness directly undermines reading proficiency, the leading indicator of long-term academic and life success. This could lead to the child losing interest and a motivation to learn. With each subsequent year of education, the child's achievement gap only widens.

It is safe to say that if a child <u>does not have preschool experience</u> and <u>does not attend kindergarten</u> because it is not mandatory, there is a possibility that the child's achievement gap will begin to look like and feel like a canyon.

One of the first steps in closing the achievement gap is by making kindergarten attendance mandatory.

I also support the bill requiring the Department of Education (DOE) to work collaboratively with the Executive Office of Early Learning (EOEL) to create a statewide kindergarten readiness program as this will aide in the closing of the achievement gap.

The EOEL is staffed by individuals who have experience in addressing the needs of the whole child ~ that is education, health, safety and welfare. They are also skilled in working with a variety of partners, both private and public, to address the needs of the whole child and his/her family.

Having the DOE work with the EOEL is a collaboration that will put Hawaii's keiki on a road to a successful life.

It is time for us to seriously *invest* in Hawaii's future by investing in its keiki.

To Whom It May Concern:

My name is Celia Chang Takahashi and I am an Early Childhood Professional asking you to support HB14 HD1 relating to early childhood education, as it amends the compulsory education law to make kindergarten mandatory; develops a statewide individualized kindergarten readiness tool; and establishes an individualized kindergarten readiness assessment process.

As an early childhood professional I understand & am in support of the measures outlined in this bill. As Hawaii makes strides to create & implement an early learning system, it only makes sense that mandatory kindergarten be a part of that plan as it will promote continuity in the educational experiences keiki have during their years when brain development occurs.

This measure must be implemented in order for Hawaii's youth to be properly equipped with important life skills. While the number of keiki not attending kindergarten is not large (5% according to Deborah Zysman, Executive Director of Good Beginnings Alliance testimony dated January 28, 2014), it is important that all of our keiki attend kindergarten.

The Hawaii State School Readiness Assessment (HSSRA) for the 2012 -2013 School Year estimates that approximately 43% of Hawaii's keiki *entered kindergarten without preschool experience*. (Note: The statistics for SY 2013 -2014 were not available at the time when this testimony was written.)

A lack of school readiness that is provided by quality early learning experiences prior to kindergarten (i.e., preschool) undermines reading proficiency, the leading indicator of long term academic and life success. This inevitably creates an achievement gap and

has a negative impact on the child as he/she may lose interest and motivation to learn

because he/she lacks the foundation to establish reading proficiency.

If a child <u>does not attend preschool and does not attend kindergarten because it is not</u>

mandatory, the problem is magnified making the achievement gap larger and larger.

Making kindergarten mandatory is one of the things that should be done to ensure that

the future of our keiki is a bright and successful one.

I also support the bill as it requires the Department of Education (DOE) to work

collaboratively with the Executive Office of Early Learning (EOEL) to create a statewide

kindergarten readiness program and establishes an individualized kindergarten

readiness assessment system.

The EOEL is staffed by individuals who have a diverse background that will guide them

in addressing the needs of the whole child; that is education, health, safety and welfare

~ not just the child's physical health, but his/her social and emotional health as well.

The EOEL staff also understands how important the early years are and that children

develop at their own pace. Establishing an individualized kindergarten readiness

assessment that is guided by individuals who understand child development, health,

safety and welfare insures that each child will be seen as an individual. This will, I

believe, dramatically decrease the number of children falling through the cracks and

close the achievement gap.

As an educator I am in support of HB14 HD1 as it continues to help Hawaii move

towards investing its future by investing in our keiki.

The time to invest in our keiki is now. Hawaii cannot wait any longer. The Aloha State

deserves better. Our keiki deserve better.
